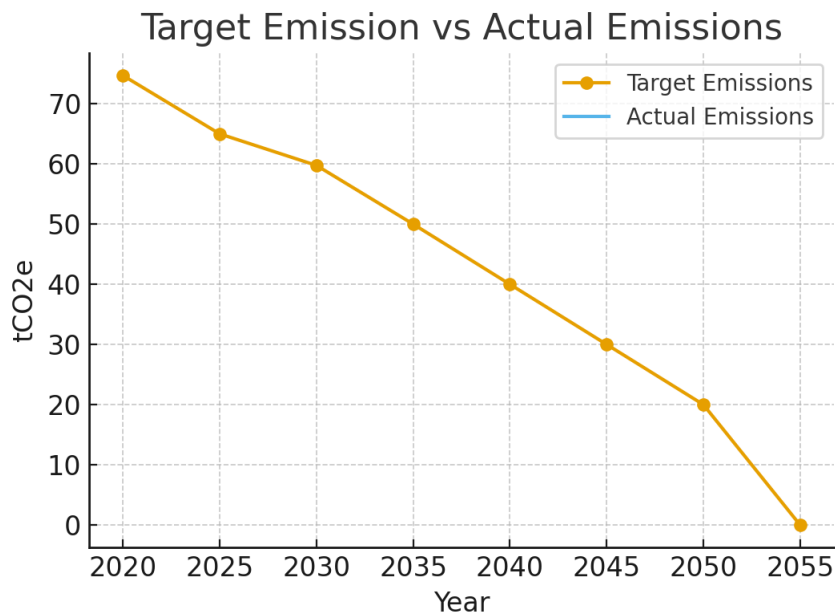

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to 59.76 tCO₂e by 2029. This is a reduction of 20%.
