MANAGEMENT DISCUSSION AND ANALYSIS



Financial Performance and Review

Operating Environment

Global economic growth remained healthy at 3.3% in CY24 consistent with the prior year. Global inflation eased to 5.7% in CY24 from 6.7% in CY23, supported by the stabilisation of supply chains post-COVID and a moderation in commodity prices. This enabled major central banks to ease monetary policy, lowering benchmark rates by 50 to 100 bps in CY24.

However, geopolitical tension and policy uncertainties, including trade tariffs, led to volatility in global markets, adversely impacting energy demand, resulting in softer prices and narrower margins. Transportation fuel margins moderated from elevated levels, and downstream chemicals margins came under significant pressure due to incremental supply additions, particularly from China.

Despite global headwinds, the Indian economy was remarkably resilient. While growth moderated to 6.5% in FY 2024-25 from 9.2% in FY 2023-24, India retained its position as the fastest growing major economy in the world.

Domestic consumption witnessed mixed trends with rural demand strengthening, and urban consumption moderating. Macro-prudential regulatory tightening of credit in FY 2023-24 led to moderation in personal credit growth to 16% in FY 2024-25, from 27% in FY 2023-24. Consumption demand remained relatively soft during the first half with general elections and peak monsoon. The festive season and Mahakumbh revived domestic markets in the second half. However, pockets of urban and rural demand are yet to fully recover.

External balances in India saw continued strength in current account with resilient services surplus (current account deficit <1% of GDP). Net services exports clocked another 14% Y-o-Y growth, driven by continued momentum in digital services and Global Capability Centres

(GCC). In the second half, capital inflows slowed as FPIs turned net sellers, leading to tighter liquidity. In response, the RBI cut the CRR by 50 bps in December, and subsequently reduced the policy repo rate by a cumulative 100 bps to 5.5% by June 2025. India remains well positioned for sustained high growth on the back of favourable demographics and a large domestic market.

Performance Overview

Reliance Industries Limited delivered a resilient performance for FY 2024-25, emphasising the strength of its India-focused, diverse business portfolio. Amidst prolonged global volatility, the Company delivered balanced and consistent growth across its businesses.

- Consolidated revenue increased by 7.1% to ₹10,71,174 crore (US\$ 125.3 billion), compared to ₹10,00,122 crore in FY 2023-24
- EBITDA grew by 2.9% to ₹1,83,422 crore (US\$ 21.5 billion) from ₹1,78,290 crore in the previous year, with consumer businesses contributing over 50% of consolidated EBITDA
- PAT rose 2.9% year-on-year to ₹81,309 crore (US\$ 9.5 billion)

Segment Performance:

- Digital Services EBITDA grew 14.7% supported by widespread adoption of 5G and broadband across mobility, home, and enterprise segments. Tariff revision introduced during the year was well absorbed, with no adverse impact on data consumption trends.
- Retail EBITDA grew 8.6%, benefitting from productivity gains through network optimisation and improved operating metrics
- Oil and Gas EBITDA increased by 4.9% supported by a marginal increase in production from the KG D6 block
- Oil to Chemicals (O2C) EBITDA declined by 11.9%, impacted by weaker fuel cracks and lower petrochemical margins. The performance was supported by

stronger domestic demand and feedstock flexibility. The segment witness increased fuel retail sales through Jio-bp, aided by a favourable margin environment.

- Consolidated cash profit increased to ₹1,46,917 crore, compared to ₹1,41,969 crore in FY 2023-24.

Consolidated Net Debt

RI's gross debt as on 31st Mar'25 stood at ₹ 3,47,530 crore (US\$ 40.7 billion) Net debt stood at ₹ 1,17,083 crore (US\$ 13.7 billion). Robust internal cash-flow generation supported investments in growth opportunities across business, while maintaining a conservative balance sheet and investment grade credit ratings.

Capex

Capital expenditure for the financial year stood at ₹ 1,31,107 crore (US\$ 15.3 billion), adequately covered by cash profits. FY 2023-24 capex was at ₹ 1,31,769 crore. FY 2024-25 investments were largely directed towards new O2C projects, Retail store expansion, augmenting Digital Services infrastructure and building manufacturing assets in New Energy.

Standalone

Standalone RIL revenue was at ₹ 5,57,163 crore (US\$ 65.2 billion), lower by 3.1% as compared to ₹ 5,74,956 crore in FY 2023-24. EBITDA for the standalone entity fell 14.2% to ₹ 74,163 crore (US\$ 8.7 billion) from ₹ 86,393 crore for the year ago period. The O2C segment profitability was impacted by unfavourable global demand-supply balance, which was partially offset by improved upstream performance with higher volumes of gas and condensate. Standalone Profit After Tax was at ₹ 35,262 crore (US\$ 4.1 billion), down 16.1% vis-a-vis ₹ 42,042 crore last year.

Movement in Key Financial Ratios

The net capital turnover ratio improved from 25.43 in FY 2023-24 to 47.92 in FY 2024-25, due to reduction in net working capital.

The operating margin ratio declined to 7.2% in FY 2024-25 as against 9.8% in previous year primarily due to weaker transportation fuels and downstream chemical margins.

The return on net worth* fell to 8.2% in FY 2024-25 as against 10.3% in previous year due to decline in O2C earnings.

Liquidity and Capital Resources

Macro Environment

FY 2024-25 witnessed high volatility in financial markets. In India, first half of the financial year saw global outperformance of Indian assets driven by healthy growth momentum, continued improvement in fiscal health, which led to prospect of rating upgrade, and bond index inclusion flows. Softening global yield environment helped India benchmark 10y G-sec yield to ease decisively below 7%, while rupee remained stable.

However, second half of the financial year saw large outflows from foreign portfolio investors, softening of growth momentum in India and resurgence of China as an investment destination. This had a depreciative effect on INR and tightened banking system liquidity. As a result, from December 2024 onwards, RBI began easing financial conditions through a mix of CRR cut, Repo rate cuts and injection of rupee liquidity.

Fund Raising

Despite a volatile environment, RIL successfully executed a multi-currency, multi-instrument financing strategy,

achieving an optimal capital structure at competitive costs. The proceeds were primarily utilised to fund green capital expenditures and to refinance upcoming debt maturities.

Offshore Facilities

Syndicated Term Loan Facilities (~\$3 billion equivalent)

The Company secured these facilities to refinance maturing debt obligations.

ECA Supported Facilities (~\$1 billion equivalent)

RIL tied up ~\$1 billion equivalent green SACE Push facilities supported by Italian

Export Credit Agency (SACE) to finance capital expenditure towards eligible green projects. This is the first such fully green-labelled facility for the Company.

Liquidity Management

RIL maintains a robust liquidity management framework to ensure financial flexibility and resilience in all market conditions. The Company leveraged a diverse funding strategy and efficiently managed working capital. RIL's surplus funds were deployed in stable yield instruments, insulated from unfavourable market movements to ensure immediate access to liquidity.

RIL continues to be rated two notches above sovereign by S&P and one notch above sovereign by Moody's.

Way Forward

According to a recent report by the Boston Consulting Group and the Retailers Association of India, India's retail sector is projected to reach an impressive ₹ 190 lakh crore by 2034, growing at a compounded annual growth rate (CAGR) of 9%. The share of organised retail constitutes 18% of the total retail market, while the unorganised segment, characterised by presence of millions of small kiranas, constitutes the remaining 82%.

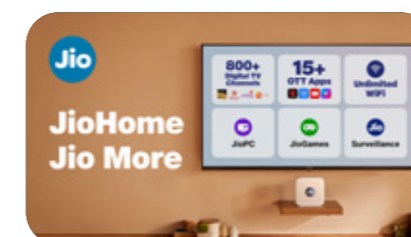
Industry Overview

Digital becoming a growth engine for the economy

With ~950 million broadband users, India's digital economy is growing at a remarkable pace, driving economic growth, employment, and sustainable development. According to Government of India estimates, digital economy is expected to grow at twice the pace of the overall economy and contribute to one-fifth of the national income by 2030. Key drivers of this growth include the rapid adoption of AI, cloud services, and the rise of global capability centres (GCCs) in the country. Jio is actively partnering with Government of India in its INDIAai mission to build a comprehensive AI ecosystem that democratizes computer access and develops indigenous AI capabilities.

Broadband adoption accelerates with 5G and Fixed Wireless

Improving device ecosystem and the pan-India rollout of 5G have boosted digital adoption. Jio significantly expanded its 5G user base in India with high per capita data usage. According to Ericsson Mobility Report, 5G subscriptions in India are expected to reach around 970 million by the end of 2030, accounting for 74% of mobile subscriptions. The rollout of fixed wireless infrastructure has accelerated the growth of fixed broadband in the country. Fixed wireless technology with point-to-multi-point radios is taking services to currently underserved semi urban/rural areas. India's fixed broadband user base is expected to grow multifold from the current 47 million premises over the next few years.



Regulatory Developments

The key regulatory developments during the year were as follows:

- **Spectrum Auction** was conducted in June 2024 and Jio enhanced its holdings in 1800 MHz band in Bihar and West Bengal. Jio's spectrum footprint increased to 26,801 MHz (uplink + downlink), solidifying its leadership position.
- Government has issued the draft Rules under **Digital Personal Data Protection Act, 2023** to protect the digital personal data of Indian citizens for consultation.
- TRAI issued revised guidelines under the **Telecom Commercial Communications Customer Preference (Second Amendment) Regulations, 2025** to strengthen spam management.
- TRAI has released recommendations on **Terms and Conditions for the Assignment of Spectrum for Satellite-Based Commercial Communication Services**.

Revenue and EBITDA growth for the Digital Services business in FY 2024-25 were 15.9% and 14.7% Y-o-Y, led by impact of tariff hike in mobility, increasing penetration of the homes business and scale-up of digital platforms. Customer engagement on the Jio network remained robust, with average per capita data and voice usage at 33.6 GB and 1,027 minutes per month across overall subscriber base of 488.2 million for the quarter ending March 2025.

Jio has led every communication technology transition in India

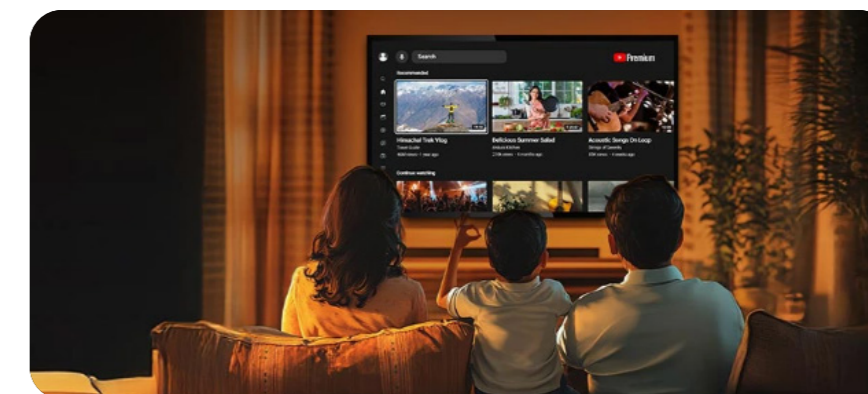
In less than a decade, Jio has driven India's transition from data darkness to data abundance. This has been enabled by Jio's vision and ahead of the curve investments on 4G LTE pre-2016, Fiber-To-The-Home in 2018, Standalone 5G in 2022, and FWA in 2024. Resultantly, Jio is now the world's largest data operator carrying over 17 exabytes of data traffic monthly with a ~60% share of wireless data traffic in India.

Jio continues to work on future communication technologies and is actively researching and developing 6G technology, aiming to be a global leader in its development and deployment. To augment our technology leadership in building terrestrial networks, Jio is also building its own Satellite communication platform and partnering with SpaceX to offer Starlink's broadband internet services to its customers in India.

Jio strengthens market leadership across mobility and fixed broadband

As of March 2025, Jio had ~191 million 5G users on its network contributing ~45% of its wireless data traffic. Jio's True5G network is the most awarded and shows a significant lead on performance and availability metrics across most network performance measurement platforms like OpenSignal and Ookla.

Jio has connected ~18 million homes as of the end of FY 2024-25 and has accounted for ~85% of the total new additions in the industry during the fiscal year. Jio's AirFiber solution has been the primary reason for the acceleration in pace of home connects extending reach to all parts of the country, especially beyond the top 1,000 cities. Jio remains confident of connecting 100 million homes with a combination of Fiber and AirFiber broadband solutions bundled with digital TV and on-demand entertainment.

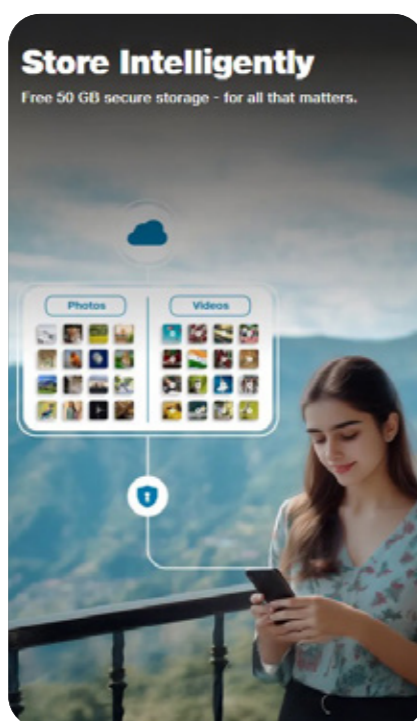


Ecosystem approach to Consumer and Enterprise Digital Services

This is complemented by MyJio, India's largest connectivity self-care application which serves as a platform to access the entire digital services offering across Jio and its partner ecosystem.

Jio's Set-top box is a digital gateway with high engagement levels and average daily usage of over 5 hours in every home. Our new offerings, the JioAI Cloud, a consumer cloud storage service, and JioPC a cloud based scalable compute platform would make AI accessible across our customer base.

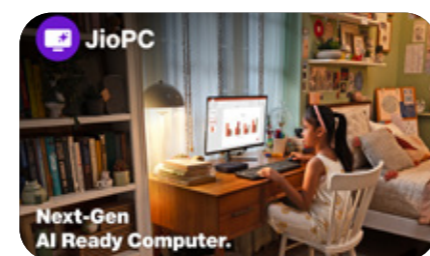
Jio is also growing as an end-to-end managed services partner of enterprises offering best in industry

Jio will leverage its expertise in infrastructure, networking, operations, software and data, and collaborate with its global partners to enable world's lowest AI inferencing cost in India to make AI available Everywhere for Everyone.

Industry Overview

Indian Media and Entertainment sector grew 3.3% Y-o-Y in 2024 to reach ₹ 2.5 trillion. Video continued to command the lion's share of revenues and drove content consumption across platforms.

Digital continues to drive growth in M&E Sector

Digital segment is expected to grow at a CAGR of 11.2% over 2024-27, reaching ₹ 1.1 trillion and representing over 50% of the overall 'big media' (TV, Digital, Print). With an estimated 945 million broadband subscribers, led by mobile, and around 70% of time spent on small-screens going towards media consumption, online video is expected to drive long-term growth of the media segment.

JioStar reinforced its leadership in the Indian television landscape by delivering an unmatched content slate across genres and languages.

In the Hindi GEC segment, 9 out of the top 10 shows belonged to JioStar; Star Plus remained the undisputed leader with a 27% market share.

The regional portfolio delivered exceptional performance, with Star Pravah dominating Marathi GEC with a 50% market share. In Bangla, Star Jalsha strengthened its leadership, increasing its market share from 43% to 47%, with 6 of the top 10 shows.

Asianet continued its supremacy in Malayalam GEC with a 42% market share and the top 9 shows of the genre, while Star Maa led Telugu GEC with 39% market share. In Tamil too, Star Vijay emerged as a leader with 32% market share and 5 of the top 10 shows.

JioStar's Kids, English, and Youth portfolios retained their #1 position in their respective segments.

The Champions Trophy 2025 was a defining moment, delivering peak concurrency of 61.2 million viewers, surpassing previous benchmarks. IPL viewership (reach) hit an all-time high of 652 million as multiple viewer centric innovations drove higher engagement.

Beyond sports, JioHotstar is transforming how audiences experience culture and entertainment through immersive live streaming. Mahashivratri: The Divine Night amassed 39 million views, and the Coldplay Music of the Spheres concert, streamed exclusively on JioHotstar, garnered 8.3 million views.



JioHotstar also introduced 'Sparks', a flagship initiative spotlighting India's biggest digital creators through engaging formats. With an unparalleled mix of sports, movies, originals, and live events, JioHotstar remains the ultimate destination for digital entertainment.

Network 18

News Business

Network18's TV News portfolio is now the #1 ranked news network in the country as it garnered a record-high viewership share. It made significant gains in key regional markets like Marathi (#1), Bengali (#1), and Kannada (#2), strengthening its pan-India position. The network fortified its leadership positions in the national markets – Hindi (News18 India), English (CNN News18) and English Business News (CNBC TV18). Network18's digital news portfolio also exited the year as the #1 online news publisher with a clear leadership in financial news segment where Moneycontrol has consistently maintained the numero uno status, both in terms of reach as well as engagement. Moneycontrol Pro crossed a significant

milestone of 1 million paid subscribers, establishing its position as India's most subscribed digital news platform. Moneycontrol's fintech business gathered steam as it saw a strong traction for its lending offering. Firstpost continued to build a loyal audience on YouTube, as India's top global news destination, crossing 7 million subscribers with 70% growth during the year.

The next leg of growth in RIL's M&E segment will be driven by innovative content formats and newer monetisation capabilities by scaling advertising and subscriptions across platforms through a broader advertiser base, Ad-tech innovation, and compelling subscription offerings.

Notable theatrical triumphs included "Stree 2", "Singham Again" and "Sky Force", with "Stree 2" emerging as the highest-grossing Hindi film of all time.

With a commitment to platform-agnostic, high-quality storytelling, Jio Studios' films and originals have consistently broken viewership records across leading platforms, including Netflix, Amazon Prime Video, ZEE5, JioHotstar, Colors, Zee, and Star Network. "Laapataa Ladies" ranked among the Top 3 most-watched Hindi

films on Netflix, dominating global charts for weeks. The O2C business includes world-class assets comprising refineries and petrochemical units that are deeply and uniquely integrated across sites, along with logistics and supply chain infrastructure.

Industry Overview

Transportation Fuels

In FY 2024-25, the transportation fuel sector faced demand growth challenges on the back of geopolitics, energy transition, efficiency improvement, and economic concerns. Oil demand rose by 0.9 mb/d to 103.1 mb/d, while supply also increased by 1.1 mb/d to 103.3 mb/d. Brent price averaged \$ 78.2 per barrel amidst volatility. In CY24, Refinery throughput increased by 600 kb/d to reach 82.9 mb/d, led by new refineries capacity additions and stronger non-OECD throughputs.

In CY24, gasoline demand increased by only 89 kb/d and diesel growth decelerated by 158 kb/d. Major demand came from jet fuel, which surged by 397 kb/d. Key factors to watch in 2025 would be stagnating demand in China (EV penetration), aviation growth in Asia, geopolitical uncertainties and new economic policies (tariffs & sanctions).

With consistent government push for roads and air connectivity, Indian Petroleum Product demand rose to an all-time high of 239 MMTPA at 2.1% Y-o-Y growth. Climate consciousness has led to a sustained rise in charging network presence, (close to 40,000 charging stations) with a 6 million EV parc. CNG-CBG vehicle parc has also touched 2 million.

OIL TO CHEMICALS

Polymers & Elastomers

Global ethylene demand increased by 2.2% Y-o-Y to 185 MMT in CY24 with capacity addition of 4.6 MMT resulting in a higher operating rate by 1.9%.

Global Polymer demand increased to 254 MMT in CY24, compared to 247 MMT in CY23. In CY24, Global PE, PP, and PVC demand grew by 3.0%, 3.0% and 2.9%, respectively & domestic Polymer demand grew by 4.7%.

In FY 2024-25, domestic PP demand grew by 8.2%, driven by automotive, industrial and food packaging and PVC demand grew by 12.1%, led by agriculture and infrastructure sectors. LLDPE and LDPE demand grew by 8.0% and 0.7% respectively on account of demand from the packaging segment.

In FY 2024-25, US Ethane price was at 21 cpg, down by 9.0% Y-o-Y due to higher production of Ethane and Natural gas in US.

Global demand for E-SBR and PBR increased by 2.0% and 3.9% respectively in CY24 due to growth in light vehicle sector. During FY 2024-25, domestic SBR and PBR markets expanded by 2.7% and 11.7% Y-o-Y respectively driven by robust growth for Automobile OEMs.

Intermediates and Polyesters

In CY24, global Intermediates demand rose by 5.9% to 173 MMT though markets remained under pressure due to volatility in crude prices.

Global PX demand grew by 7.6% at 55 MMT in CY24 led by new capacity additions. PTA and MEG witnessed 5.4% and 5.0% growth respectively due to high downstream polyester operating rates.

Global Polyester demand grew by 4.9% to 93 MMT in CY24, driven by improvement in demand from Asian countries. Domestic Polyester demand grew by 5.4% in FY 2024-25. PET grew at 11.5% driven by higher demand from beverages segment.

PSF and PFY demand was up 3.0% & 3.5% respectively due to improvement in downstream operations. Textile demand from India improved as political turmoil in Bangladesh made customers divert orders to India.

O2C Revenue for FY 2024-25 increased by 11.0% Y-o-Y to ₹ 6,26,921 crore (\$ 73.4 billion) primarily on account of higher volumes and increased domestic product placement.

O2C EBITDA for FY 2024-25 was lower at ₹ 54,988 crore (US\$ 6.4 billion) due to weaker transportation fuel cracks and multi-year low downstream chemical margins. Earnings were supported by higher volumes, operational flexibility, efficient feedstock sourcing & higher domestic product placement.

Transportation Fuel

RIL's transportation fuel segment in overall production meant for sale was higher driven by higher throughput and healthy domestic demand. Despite a challenging margin environment due to heightened refinery supply and global dynamics, RIL effectively managed the business environment. Cracks in key fuel categories declined: Singapore gasoline 92 RON cracks averaged \$6.9/bbl (vs \$11.6/bbl), gasoil 10-ppm cracks at \$14.4/bbl (vs \$23.0/bbl), and jet/kerosene cracks at \$13.6/bbl (vs \$21.2/bbl). RIL's strategic positioning and efficient operations ensured stability, exemplifying resilience, and adaptability amidst market complexities.

Jio-bp has a mobility station network of 1,916 outlets. With industry-leading value propositions including active technology powered high-performance fuels, Jio-bp registered all-time high

sales in fleet HSD, on-demand HSD and MS. HSD/MS sales grew at 33.3%/41.6% against industry average of 1.2%/7.5%. With operational excellence, Jio-bp clocked 62% growth in ATF sales. Through innovative mobility solutions including charging stations, Jio-bp is playing a key role in India's transition to low carbon fuels. Jio-bp Pulse has grown network to over 5,750 live charging points at 701 unique sites with industry leading charger uptime.

Polymers and Elastomers

Polymer prices remained volatile during FY 2024-25 amidst global capacity additions, slowdown in consumption and recessionary concerns in developed markets. Polymer margins contracted during FY 2024-25 with PP-Naphtha, HDPE-Naphtha and PVC margins down by 2.2%, 9.5% and 3.7%, respectively. US Ethane prices declined

by 9.0% Y-o-Y and Asian Naphtha prices increased by 4.1% Y-o-Y.

Intermediates and Polyesters

In FY 2024-25, PX-Naphtha margins decreased by 34.4%, due to weak global demand and oversupply. Integrated producers continued to optimise production based on PX vs. gasoline economics. PTA-PX margins decreased by 11.6% due to significant capacity expansion of PTA in China. MEG-Naphtha margin surged 45.9% from a low base, driven by firm product prices due to low inventory in China.

PET margins weakened due to substantial capacity increase in China and sluggish demand growth in Western countries. Filament and Staple margins improved due to slowdown in capacity additions and improved China demand.

Outlook

Oil demand is likely to maintain growth despite EV penetrations, largely driven by strong economic growth, China stimulus measures and possible easing of geopolitical tension. Continuing geopolitical and tariff-related uncertainties may affect trade flows and demand-supply balance.

In 2025, ramp-up of new refineries may lead to weaker product cracks. However, expected closures could create upside potential for refining margins. Fuel demand in India is expected to remain healthy with increasing economic activity.

Demand for downstream chemical products in India is expected to grow ahead of GDP growth rate, driven by demand from infrastructure, packaging, automobiles and agriculture.

Oil and Gas



Industry Overview

In 2024, global oil demand rose by 0.9 mb/d to 103.1 mb/d, while supply also increased by 1.1 mb/d to 103.3 mb/d. Natural gas consumption hit an all-time high, with global demand up 2.8%, driven by strong growth in Asia. Stronger global demand, geopolitical tension and delay in LNG projects continue to support LNG prices. For FY 2024-25, India's natural gas demand improved by 3.7% to 195 MMSCMD. Increasing infrastructure availability is likely to drive domestic gas demand growth.

Strategic Objective

Deliver sustainable growth and maximise stakeholder value by safely and responsibly exploring, producing, and marketing hydrocarbons, while enhancing productivity to meet India's energy needs. Key focus is on reserves accretion via commercialisation of discovered resources and infrastructure-led exploration.

The Exploration & Production (E&P) business remains firmly focused on safeguarding health, safety, and security of its people and assets, alongside efforts to stabilise and progressively enhance production performance.

In the KG Basin, strategic initiatives are being pursued to commercialise additional discovered resources, aimed at augmenting production.

In the Coal Bed Methane (CBM) Business, we have successfully reversed the declining trend in output through the adoption of Multilateral Well (MLW) technology.

Average natural gas production from the E&P business stood at 28.8 MMSCMD, contributing approximately 30% to India's overall domestic gas supply.

Business Performance

Revenues and EBITDA were up 3.2% and 4.9% respectively, primarily due to higher gas and condensate production in KG D6, CBM, partly offset by lower price realisation.

KG Basin

KG D6 Deepwater Production Update

KG D6, comprising R Cluster, Satellite Cluster, and MJ fields, continues to deliver strong performance with ~28 MMSCMD of gas and ~21,000 bbl/day of oil and condensate produced in FY 2024-25, aligned with expectations. The field has set global benchmarks, achieving 99.9% uptime and over 14 years of incident-free operations.

Based on field performance, three new wells in R Cluster and one in Satellite Cluster are planned, targeting an additional ~240 BCF of gas recovery.

Exploration Strategy

RIL's exploration strategy is focused on leveraging existing infrastructure. Blocks KGUDWHP-2018/1 (KG UDW1) & KG-UDWHP-2022/1 (KG UDW2), awarded under OALP Rounds II and VIII, have received Petroleum Exploration Licenses. Exploration surveys are underway to pursue prospects.

Coal Bed Methane

RIL is producing Coal Bed Methane (CBM) from Block SP (West)-CBM-2001/1, with over 320 wells contributing to an average output of ~0.8 MMSCMD in FY 2024-25, a 30% year-on-year increase. As part of further production augmentation, we have completed first 40-well multilateral horizontal well (MLW) campaign. This has helped in successfully reversing field decline and boosting production. A second 40-well campaign has commenced in April 2025.

Reliance Gas Pipeline Limited, an RIL subsidiary, operates the 302 km Shahdol-Phulpur pipeline, linking CBM fields to the National Gas Grid and enabling access to consumers nationwide.

Update on Arbitrations and Other Legal Issues

There are certain disputes relating to the E&P Business of the Company which are presently sub judice before various courts and tribunals. The details of these disputes have been provided in the notes to accounts (refer Note 33.3 and 33.4 of Standalone Financial Statements).

Dhirubhai Ambani Green Energy Giga Complex: Creating the Future, at Scale

The complex is one of the world's largest integrated renewable manufacturing hubs.

- Recently, RIL commissioned its first solar GW+ line with BIS certification.
- RIL is well on its way to establish 10 GW fully integrated solar PV manufacturing from polysilicon to ingot and wafer to cell/module along with glass and encapsulant and expand it in modular fashion thereafter.
- RIL is also progressing rapidly to establish a 30GWh modular battery giga-factory for cell, packs and containerised BESS systems and backward integrate into battery materials.
- RIL is on track to establish a fully automated, multi-GW electrolyser manufacturing facility by end 2026.
- Reliance has secured exclusive technology licensing from Nel ASA



for alkaline electrolysers (India and captive global).

- RIL has significantly progressed project development work on the arid wasteland leased in Kutch, which is advancing at a rapid pace.
- RIL has also been awarded key transmission projects (Lakadia-1 and Kandla) securing power connectivity for our captive requirements from Kutch as well as for our green chemical projects.

Bio Energy: Turning Waste into Wealth

India's vast biomass reserves—nearly 230 million tonnes of surplus non-cattle feed—represent a dual opportunity: reduce air pollution and unlock rural economic value.

Since its inception in 2023, Reliance Bio Energy has become India's largest integrated bioenergy platform. In FY 2024-25, we:

- Operationalised 7 CBG plant with ~130 TPD production capacity (0.5 lac TPA). These plants shall also produce 2 lacs TPA of high quality Fermented Organic Manure (FOM).
- On track to establish 55 CBG plants including integrated CBG Hub with a cumulative capacity of 0.4 MTPA of CBG and 2 MTPA of organic manure.
- Built the world's largest bioenergy R&D centre in Jamnagar, focused on microbial innovation, crop science, automation, and plant energy self-reliance.

Our partnerships with state governments and research institutions like IGFR Jhansi are accelerating innovation in drought-resistant energy crops and salinity-tolerant cultivation.

Operating Management System (OMS) drives safe, sustainable, reliable, and compliant operations and Change Agents for Safety, Health, and Workplace Environment (CASHE) empowers employees to continually improve safety. Leadership's strong HSE and sustainability commitment drives a zero-incident culture, protecting stakeholders and aligning with RIL's operational excellence vision.

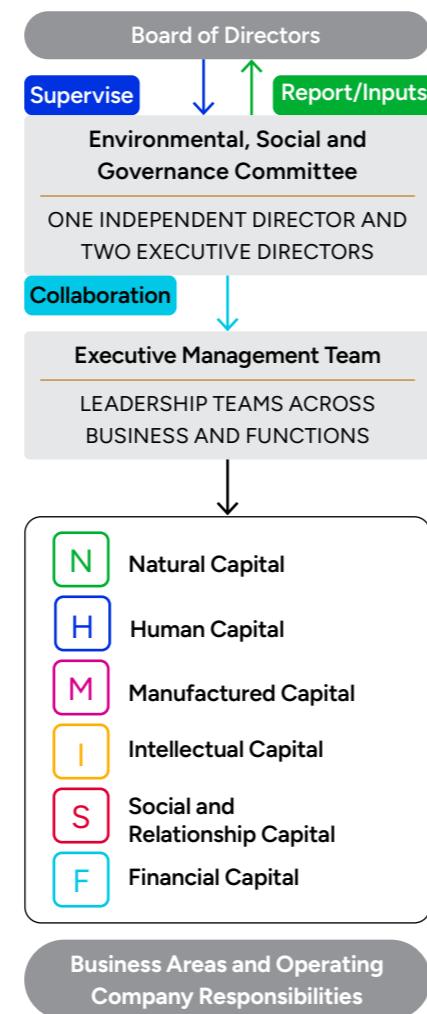
Board Oversight

Through technological advancements and large-scale infrastructure development, Reliance has intensified its efforts towards reducing carbon emissions and building a holistic green energy ecosystem. This transition from fossil fuels to greener energy solutions—requiring significant investments in skills, technology and large-scale manufacturing—continues to reinforce the Company's commitment to developing its New Materials and New Energy business.

With a mission to position India as a global leader in energy transition, Reliance is investing in domestic technology and manufacturing capabilities to help transform India from a net energy importer to an exporter, creating long-term value for both the nation and its shareholders.

The Reliance Commitment

To achieve its ambitious Net Carbon Zero target by 2035, Reliance announced plans to:

- **Establish** and enable **100 GW** of renewable energy by 2030
- **Invest** in the value chain, partnerships and future technologies, including upstream and downstream industries

- **Transform** its business to Net Carbon Zero operation

The Company is also fostering extensive in-house research and development to deliver advanced solutions at cost-competitive levels.

Reliance is actively developing a comprehensive green energy ecosystem, utilising new technologies and pursuing innovative approaches, which contribute to carbon emission reduction and a more sustainable future for India.

Reliance has made a strong start on the ambitious journey to become

Net Carbon Zero by 2035. The Company envisions becoming one of the world's leading New Energy and New Materials company over a period of 10 years through a strategic focus on clean energy transition, making CO₂ a recyclable resource and replacing transportation fuel.

Clean Energy Transition

Reliance is making significant strides in developing the Dhirubhai Ambani Green Energy Giga Complex spanning 5,000 acres in Jamnagar. The Solar and Battery Giga-Factories are progressing rapidly, with engineering completed, procurement finalised, and equipment deliveries expected in 2025. The first giga-watt+ scale solar PV module line, with BIS certification, commenced operations recently.

Reliance is building a 30 GWh advanced battery giga factory scheduled for progressive commissioning over 2025/2026. This facility will initially assemble Battery Energy Storage Systems (BESS) and then integrate backward into cell manufacturing and battery chemicals, creating the world's only fully integrated battery giga-factory to drive value chain synergies. Additionally, Reliance plans to operationalise a multi-GW electrolyser facility to bolster green hydrogen capabilities. Reliance and Nel Hydrogen Electrolyser AS have entered a technology licensing agreement, granting RIL an exclusive license to manufacture and utilise Nel's alkaline electrolyzers in India and for

global captive use. The Company also acquired Nauyaan Shipyard near Dahej for electrolyser and fabrication capacity.

The Company has begun land development in Kutch where the Company has been allocated significant land parcels with high solar irradiance. The Company can deliver nearly 150 billion units of electricity from Kutch. The Company also has access to 2000 acres of land in Kandla for green chemicals production and evacuation. Two transmission projects - Lakadia 1 and Kandla - were awarded to RIL, enhancing its clean energy transmission footprint. Reliance continues to explore cutting-edge technologies to convert CO₂ into valuable products, with carbon capture and utilisation playing a pivotal role.

Reliance is pioneering efforts to shift from traditional fuels to cleaner alternatives - such as green hydrogen and renewable electricity. Key focus areas include transitioning from traditional transportation fuels to chemical building blocks and integrating them with downstream derivatives powered by solar, and battery solutions. During the year, Jio-bp launched the Charger on Wheels (COW) mobile charging unit and unveiled southern India's largest public EV charging hub, while also piloting a 'Green Energy Open Access' project. Additionally, Jio-bp has expanded its CBG/CNG offerings across its retail outlets.

Approach to Climate-related Disclosures

Reliance acknowledges that climate-related disclosures are more than just corporate responsibilities. The Company's climate related disclosure emphasises Governance, Strategy and Risk Management in line with the Task Force on Climate-

Related Financial Disclosures (TCFD) guidelines. These guidelines are now integrated into the broader IFRS S2 Climate-related Disclosures under the ISSB Standards.

Governance

Reliance is enhancing its approach to embedding climate change considerations into both strategic and operational decision-making. The Board plays a key role in overseeing, reviewing and guiding the Company's energy transition strategy through ongoing engagement with management and external experts.

The Board is supported by the ESG Committee, which helps identify and assess emerging climate risks and opportunities, evaluates their potential impacts on the business and stakeholders, and proposes mitigation strategies or opportunities for growth. Additionally, the Board supervises overall risk management and internal controls through dedicated committees.

The ESG Committee convenes quarterly to review the Company's sustainability initiatives, progress made, advancements towards goals and targets, and upcoming plans. A comprehensive overview of the Committee proceedings is reported back to the Board.

As the shift towards low-carbon energy accelerates, relevant expertise is crucial to tackling associated complexities. The Board brings knowledge in areas such as operations, risk management, strategic planning and regulatory frameworks to address climate challenges.

When necessary, knowledge sessions are conducted to enhance Board members' understanding of regulatory updates, best practices and implications for the Company.

Guided by a capable Board, Reliance's management plays a central role in evaluating and managing climate-related risks and opportunities while monitoring climate progress. Dedicated teams reporting to the Executive Committee focus on decarbonisation, New Energy initiatives and related plans. The Executive Committee ensures strategic alignment with the Net Carbon Zero objective and keeps the Board informed about climate-related metrics, risks, energy transition opportunities, partnerships and disclosures.

Risk Management

Reliance has a structured framework in place for identifying, assessing and managing climate-related business risks, in accordance with TCFD recommendations. This includes physical risks (both acute and chronic) as well as transition risks such as policy changes, regulatory shifts, market fluctuations, technological advancements and reputational concerns. Reliance integrates these risks within its Enterprise Risk Management (ERM) framework, allowing for effective risk identification, resource allocation and evaluation of response strategies.

Board committees regularly review risk mitigation strategies and governance mechanisms, ensuring operational stability, reducing disruptions, leveraging new opportunities and consistently delivering stakeholder value.

Strategy

Reliance has formulated a comprehensive climate change and energy transition strategy, addressing the challenges and opportunities in this evolving landscape. This strategy is based on an in-depth analysis of material climate-related risks and opportunities, factoring in shifting regulations and stakeholder expectations.

Just Transition: Reliance understands that a 'just transition' is essential to navigate the challenges posed by the shift towards cleaner energy sources in line with the broader goals of environmental sustainability, social equity and economic resilience. The Company collaborates with leading academic institutions in India to conduct research and development for low-carbon solutions. Emphasising the 'Make in India' approach, Reliance is committed to advancing its vision of positioning India as a world leader in energy transition by investing in the promotion of domestically developed products and technologies and empowering its talent resource pool to actively embrace the technologies of the future.

Metrics and Targets

Reliance assesses and oversees its initiatives concerning climate-related risks, opportunities and strategies by continuously monitoring key metrics and assessing performance against established targets. These metrics play a pivotal role in enabling well-informed decision-making and offer insights into the Company's advancements towards achieving its objective of becoming Net Carbon Zero by 2035.

Renewable energy consumption, overall energy consumption, energy savings due to conservation efforts and GHG

emissions are the key metrics that the Company monitors for measuring progress against its Net Carbon Zero commitment.

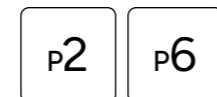

Management Approach

Reliance has established a robust governance framework to oversee its natural capital consumption, prioritising key material topics. The Board, through

its Committees, provides strategic oversight, ensuring alignment with sustainability goals. The Company's Health, Safety and Environment (HSE) Policy is underpinned by the Operating Management System (OMS) which systematically drives safe, reliable, sustainable and compliant operations across business units. The Safety and Operational Risk (S&OR) function provides independent oversight on the quality of implementation of the OMS requirements and conducts independent reviews and continuously evaluates business strategies. Regular audits, assessments and monitoring, assurance processes ensure conformance to company's HSE requirements and adherence to environmental regulations, reinforcing the Company's commitment to responsible resource management.

Managing Environmental Impacts

Reliance implements an environmental management framework to minimise environmental impact and enhance efficiency, focusing on optimising energy use, reducing emissions, recycling and reusing water, and minimising and disposing waste responsibly. Advanced technologies, including Continuous Emission Monitoring System (CEMS), enable real-time monitoring of air pollutants, including SOx, NOx and TPM, while targeted energy conservation initiatives have been introduced across facilities.

Climate Change

Reliance is steadily progressing towards its goal of achieving Net Carbon Zero by 2035, with a strategic focus on renewable energy transition, carbon capture and utilisation, and industrial decarbonisation. At the core of this vision is the ambition to establish Reliance as a global leader in New Energy and New Materials by advancing clean energy transition, repurposing CO₂ as a recyclable resource and replacing conventional transportation fuels with sustainable alternatives.

In addition to progress toward Net Carbon Zero, Reliance is expanding its Compressed Biogas (CBG) operations. In 2025, Reliance is on track to establish 55 operating CBG plants and initiate integrated CBG hubs, with a cumulative capacity of 0.4 million metric tonnes of CBG and 2 million metric tonnes of Fermented Organic Manure (FOM) annually.

Harnessing this untapped potential, can reduce LNG imports and drive a powerful shift towards a cleaner and greener energy future. This initiative converts *Anna Datas* (food producers) into *Urja Datas* (energy producers) and will create employment. The Company has also established the world's largest bio-energy deep-tech R&D centre in Jamnagar.

At Reliance, transformation is the key to energy sustainability. The Reliance Jamnagar Manufacturing Division

(JMD) has successfully connected with the Central Transmission Utility (CTU) and started importing power, boosting power cycle efficiency by enabling the shutdown of the condensing Steam Turbo Generator (STG) and paving the way for future green power intake through the grid. Silvassa Manufacturing division, replaced the fuel oil with natural gas in its Dow vaporisers and boilers, resulting in reduction of GHG emissions. In addition, other manufacturing sites (Hazira, Dahej, Hoshiarpur and Barabanki) continued the usage of biomass as co-firing.

Reliance Retail continues to drive sustainability through energy-efficient infrastructure, responsible operations and eco-friendly packaging across operations.

Jio has committed to decarbonise along the 1.5°C pathway, validated by SBTi. The company undertakes multiple emission-reduction initiatives, including selection of energy efficient technology and equipment, solarisation and other energy efficiency measures. In FY 2024-25, Jio's emissions reporting boundary excludes sites where Jio doesn't have operational control, and is aligned with its financial reporting boundary. RJIL's Scope 1 and Scope 2 GHG emissions for FY 2024-25 is 0.06 MMT CO₂e and 1.05 MMT CO₂e, respectively. For comparative analysis, RJIL's FY 2023-24 Scope 1 and Scope 2 GHG emissions is restated as 0.06 MMT CO₂e and 0.92 MMT CO₂e.

Energy Efficiency of Operations

Reliance continued to capitalise on energy-saving opportunities, including process modification projects, waste heat recovery systems and technological upgrades to equipment. Through these initiatives, O2C and E&P achieved energy savings of 2.3 Million GJ in FY 2024-25.

Reliance's energy management approach is guided by the core principles of optimising energy use, cost-effective renewable energy consumption and equipment upgrades to reduce carbon intensity. During FY 2024-25, total energy consumption for O2C and E&P was 522 Million GJ, with 5.4 Million GJ sourced from renewable sources. This year, the volume of flared and vented hydrocarbons was 0.10 Million MT.

GSMAi, in its March 2025 report on energy benchmarking study recognised that Energy/Data Traffic (kWh/GB) for Jio is around ~30% of the global average. In FY 2024-25, Jio's energy reporting boundary excludes sites where Jio doesn't have operational

control, and is aligned with its financial reporting boundary. RJIL's total energy consumption for FY 2024-25 is 63,53,629 GJ. For comparative analysis, RJIL's FY 2023-24 energy consumption is restated as 57,78,196 GJ.

Jio is focused on 100% renewable electricity by FY 2029-30. Jio has installed over 212 MWp of solar power at more than 23,699 sites (at both owned and third-party sites) nationwide. Additionally, Jio has also setup centralised solar plant of 35 MWp capacity at Bidar, Karnataka.

Ecosystem and Biodiversity

Reliance is committed to biodiversity conservation and strives to achieve a net positive environmental impact. Across India, the Company has greenbelts spanning 6,500+ hectares, and has planted over 2.48 Crore saplings cumulatively, including more than 1,00,346 saplings in FY 2024-25. The Jamnagar complex, once arid, now experiences lower temperatures and improved rainfall owing to the extensive green zone surrounding the refinery.

The complex boasts Asia's largest mango orchard, while its mangrove belt attracts migratory birds. Further, Reliance Industries and Reliance Foundation have established Vantara, a state-of-the-art animal rescue, conservation and rehabilitation centre in Jamnagar, Gujarat.

Waste Management and Circular Economy

Reliance maintains a strong focus on waste management and circular economy, including PET recycling, chemical recycling (pyrolysis oil), polyolefin recycling, reusing hazardous waste as alternative fuels and raw materials, and zero-waste stores. Reliance continues to advance circularity sustainable packaging, consumer adoption of R|ELAN™ fabric, commercialisation of RCAT-HTL technology and development of circular polymers. The Jamnagar integrated refining and petrochemical complex has earned the ISCC Plus certification for producing CircuRepo™ and CircuRelene™ polymers through the chemical recycling of plastic waste-based pyrolysis oil.

Water and Effluent Management

Reliance takes a comprehensive approach to reducing freshwater consumption by increasing recyclability, reusing treated water and minimising external discharge. Investments in automation and expansion of rainwater

harvesting have improved operational efficiency and lowered water usage in the Company's manufacturing. During the reporting period, Reliance* withdrew 232.53 Million kilolitres of water, 47% of which was seawater/desalinated water, discharged 38.96 Million kilolitres and recycled 110.09 Million kilolitres.

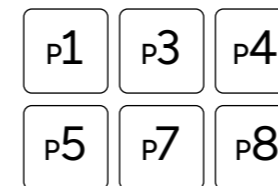

Management Approach

Reliance believes an empowered workforce is key to building a *Viksit Bharat*. Guided by its 10 Tenets of Institutional Leadership, the Company fosters empathy, inclusivity and well-being. In alignment with the Universal Declaration of Human Rights, it upholds equal opportunity and human rights, including freedom of association, speech and non-discrimination. This commitment is driven by a robust Code of Conduct, ethical governance, strong grievance redressal and transparent communication with all stakeholders.

Talent Attraction and Retention

Consistently recognised as one of India's best and largest employers, Reliance is redefining talent attraction and retention beyond the traditional direct employment model by embracing incentive-based engagement approaches that foster entrepreneurship, enhance earning potential, and align with emerging business and technological trends.

During FY 2024-25, Reliance on-boarded over 1.9 Lakh new hires. The Group's headcount expanded to over 4 Lakh.

In FY 2024-25, O2C, E&P, Retail and Jio engaged with 100% of employees through employee surveys. Owing to its people-centric approach, Reliance continues to be recognised as India's

foremost and largest employer by many external agencies, including Great Place to Work®, Unstoppable and Ambition Box.

Health, Safety and Employee Well-being

Reliance prioritises employee well-being through a robust Health, Safety and Environment (HSE) management system. The Central HSE Audit Programme and Operating Management System (OMS) ensure continuous improvement and compliance with statutory requirements for all employees and contractors.

The CASHE programme empowers employees to champion workplace safety, contributing to measurable risk reduction. In FY 2024-25, Reliance invested ₹ 874 Crore in HSE initiatives. The Lost Time Injury Frequency Rate (LTIFR) in per million man-hours was 0.12 for O2C and E&P, 0.60 for Malaysia, 0.04 for RRVL and 0.70 for RJIL, highlighting the Company's focus on safety excellence.

Additionally, the R-Swasthya and Jio Health & Wellness Academy programmes support holistic well-being through initiatives encompassing physical, mental, emotional, social, financial and spiritual well-being.

Diversity and Inclusion

The Reliance Diversity & Inclusion Charter affirms the Company's commitment to Diversity, Equity & Inclusion (DE&I) as a core value, guided by the 5E framework—Educate, Encourage, Enable, Experience and Effectiveness. Reliance upholds equal rights for all, regardless of identity or background, in line with its Code of Conduct, POSH Policy and Equal Opportunity Policy. Equal pay is ensured for all entry-level roles, regardless of gender.

Reliance O2C and E&P has conducted several programmes focusing on diversity, such as R-Aadya which supported 900 women in career advancement.

Reliance Retail reinforced DE&I through LGBTQ+ awareness sessions, unconscious bias workshops and inclusion initiatives for People with

Disabilities. It also implemented tailored programmes such as WE Women Leaders, Pragati, Jagriti, EmpowHER to foster women leadership and Back Again, a second career programme to reintegrate women who are on a career break. Learning interventions support communication, personal branding and leadership growth for women, further reinforcing an inclusive workplace culture. Due to the company's continued effort, 14.2% women are in leadership positions while 29.1% women are in revenue-generating functions.

Jio's 3rd VIBGYOR Festival spotlighted DE&I across five dimensions through awareness, belongingness, and celebration. Jio has diversity hiring programmes for women, such as Jio Shakti and Jio Customer Associate programme. A patented inclusive recruitment platform masks identity to enable skill-based hiring. All communications and content are created in 11-languages to support Jio's diverse workforce.

Talent Management

Reliance is committed to building a strong talent pipeline by identifying, developing and empowering employees through a multi-tiered talent management approach. The Company's performance management system promotes shared accountability through SMART objectives and Annual Operating Plans at both individual and team levels.

63 professionals were trained at ISB as part of the Career Acceleration Programme (CAP) 7.0 to build future-ready leaders. First Line Young Engineers at Reliance (FLYER) 4.0 enabled 44 young engineers to train at IIM-Bangalore. The Annual Talent Review Process continues to assess employees for leadership potential.

The year saw added focus on building people leadership skills both at middle and senior levels. Over 9,800 employees engaged in upskilling themselves via LinkedIn Learning and Coursera. Mission Kurukshetra, the Company's flagship innovation programme, saw 2,161 employee ideas evaluated and implemented in FY 2024-25, fostering an innovation-driven culture.

In FY 2024-25, the Graduate Engineer Trainee (GET) programme received 53,000+ registrations, offering early-career opportunities, particularly for candidates from remote regions. The 10th season of The Ultimate Pitch, Reliance's B-school competition, saw 22,811 registrations and 1,900+ business ideas, reinforcing entrepreneurial thinking.

Reliance Retail onboarded 360 trainees through its Young Leaders & Management/Graduate Trainee Programme, 266 interns through its Summer Internship Programme. Talent Accelerator Programme delivered in partnership with Jio Institute developed 27 high-potential young leaders. The School of Coaching, which offers 6-9-month certification programmes for middle and senior leaders, has already trained 300+ coaches who can provide coaching engagements on the Coaching-on-Demand technology platform. Retail's Step-Up programmes (6-12 months duration) equip store employees with essential skills, fostering internal leadership growth. Additionally, employees undergo role-readiness certifications. Reliance Samarth, an app-based training and certification platform available in seven languages, offers training in 14 trades, to pre-certify role-ready workforce. The platform has recorded over 3 lakh registrations and certified above 1.74 lakh applicants, thus enabling a steady flow of job-ready talent pool for the industry at large.

Jio follows a cohort-based talent management model driven by 15 Learning Academies. In FY 2024-25, it conducted 3,900+ programmes including the Step Up programme, spanning 6-9 months, which upskilled 160+ high-potential leaders. Over 6,000 employees completed the Career Development Programme, with 3,700+ becoming eligible for progression. The Early Career Acceleration Programme (eCAP) assessed and calibrated 140+ premier B-School hires. Jio's week-long certification programme for skilling its associates, created work opportunities across India, including in rural areas. Over 21,000 employees undertook specialised and niche skill certifications to enhance talent fungibility and future-readiness.

Labour Management and Human Rights

Reliance aligns with the UN Global Compact and ensures compliance with all regulatory and internal Code of Conduct standards. The Company engages in structured dialogue with employee unions, with significant number of permanent workers covered under collective bargaining agreements, reflecting its commitment to fair labour practices. In FY 2024-25, there were no reported cases of child labour, forced or involuntary labour or discriminatory employment. Additionally, 100% of Reliance employees underwent human rights training, reinforcing an ethical, inclusive and responsible workplace culture.

Business Ethics, Integrity and Transparency

Reliance upholds ethical business practices through a strong Code of Conduct, ensuring integrity, transparency, and accountability. The Ethics and Compliance Task Force (ECTF) monitors compliance, reviews concerns, and reports quarterly to the Audit Committee. Ethics training is mandatory at all levels. Anti-Bribery Management System (ABMS) e-learning module educates employees on anti-bribery policies, while the 'Satarkata' module empowers business partners, fostering an ethical business ecosystem. With a zero-tolerance stance on corruption, the ABMS is strengthened by ISO 37001:2016 certification.

Grievance Redressal Mechanism

RIL has implemented a robust framework through its Vigil Mechanism and Whistleblower Policy to facilitate the reporting and management of violations classified as "Reportable Matters". Under this policy, employees are encouraged to report any violations without fear of retaliation. 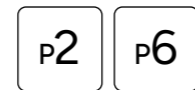
Whistleblowers can report concerns to the ECTF or directly to the Audit

Reliance continues to advance its diverse business segments through technology-driven innovation, state-of-the-art assets and advanced manufacturing processes. Its New Energy business made notable progress in bioenergy, solar modules, electrolyzers and batteries. The O2C segment remained resilient while focusing on new initiatives in vinyl chain and polyester alongside circular economy initiatives. E&P saw record production from KG D6 and India's first multi-lateral CBM wells. Reliance Retail expanded its footprint and digital reach while Jio led 5G adoption, JioAirFiber expansion and focused on AI adoption.

Additionally, Reliance actively diversifies its supplier base, reducing procurement risks, enhancing supply chain resilience and ensuring business continuity.

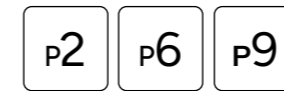

Reliance is transforming into a deep-tech company with advanced manufacturing capabilities by embedding innovative technologies across all businesses to create greater value for customers. Its team of 1,000+ scientists, engineers and specialists

fosters in-house innovation, enhancing products and services across all businesses.

Innovation and Technology

Reliance has a comprehensive IP governance framework to strengthen and manage its patent portfolio, ensuring alignment with the Company's strategic business objectives. In 2025, RIL O2C continued to advance its Intellectual Property (IP) initiatives, filing 48 new patent applications and securing approval for 28 patents. As of March 31, 2025, a total of 1,156 patents were granted to RIL. Jio has filed over 3,341 patents to date, including 1,654 patents in FY 2024-25. Jio Platforms and its subsidiaries were granted 154 patents in FY 2024-25. As of March 31, 2025, Jio held 485 patents, establishing itself as one of India's largest patent holders, particularly in 5G and 6G technologies.

Reliance's growth has always been fuelled by breakthrough technologies and innovation. The Company's comprehensive R&D strategy focuses on following areas:

Data Privacy and Cyber Security

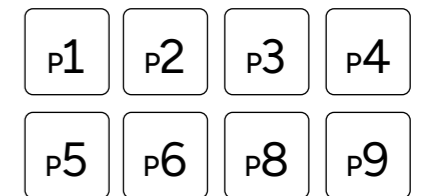
Reliance's cybersecurity strategy is built on the principles of 'Zero Trust', 'Security-by-Design' and 'Defense-in-

Depth'. The Company adheres to the principles of 'Privacy-by-Design' and 'Privacy-by-Default', implementing stringent controls to ensure data is processed ethically and legally while maintaining stakeholder trust and transparency. Reliance's key businesses are assessed and certified against global standards such as ISO 27001 (O2C, Retail), ISO 27701 (Retail), GDPR (JWC and NMACC) and PCI-DSS (Retail, RBML). The technology operations in its Digital Services business maintain ISO/IEC 27001 and ISO 27701 certifications. The Company also launched Privacy Suraksha Handbook during the Data Privacy Awareness Week 2025, which provides clear, actionable privacy best practices, especially in light of the Digital Personal Data Protection Act (DPDPA), 2023. Additionally, an in-house Generative AI-powered interactive security awareness assistant, Rovomind, has been rolled out for assisting users with context-specific guidance on cybersecurity.

Customer Satisfaction and Digital Engagement

Customer satisfaction remains central to Reliance's strategic vision. In FY 2024-25, the Company made notable strides across all business segments by delivering enhanced value through innovation and digital solutions. In the O2C segment, Reliance advanced circularity with green products and improved service efficiency using AI-driven insights and proactive customer engagement. Reliance Retail has enhanced its in-store interactions by providing staff with advanced training and requisite tools, enabling them to deliver personalised and efficient service. Reliance Jio continues to lead India's digital transformation with 488 Million mobile and fixed broadband subscribers including ~191 Million Jio True 5G users. Jio drove the growth of fixed broadband industry with ~85% share of new subscriber additions. Over 50% of new Jio AirFiber users came from beyond top 1,000 towns. Jio also launched JioAICloud with up to 100 GB free cloud storage powered by AI enabled features — enhancing digital inclusion and exceeding customer expectations.

Sustainable Supply Chain Management

Reliance upholds responsible business practices through its Business Partner

Code of Conduct (BPCOC), which sets clear expectations for ethical operations and ESG compliance among its partners. This framework promotes integrity while emphasising fair labour standards, prohibiting child labour, forced labour and discrimination and fostering safe and healthy workplaces. Reliance also collaborates with external agencies to conduct third-party assessments of high-spend suppliers, ensuring their sustainability practices align with the Company's rigorous standards.

Reliance O2C has implemented a comprehensive Sustainable Procurement Framework to embed ESG principles across its value chain. This includes governance mechanisms, Supplier Code of Conduct, adherence to standards including ISO 45001 and OSHAS 18001, SOPs, internal stakeholder trainings and regular supplier engagement including trainings and third-party assessments of suppliers.

Reliance Retail promotes inclusive growth by expanding its sourcing from tribal areas, local artisans and women entrepreneurs. Its "Crafts of India" initiative includes more than 2,500 sellers, empowering ~50,000 artisans across 24 states. Jio advanced supply chain sustainability by engaging suppliers on Scope 3 emission reductions, aligning with its 1.5°C decarbonisation pathway. The Company monitors compliance with its Supplier Code of Conduct by evaluating suppliers' performance in areas with elevated ESG risks and encourages them to adopt sustainability programmes.

Independent Practitioner's Assurance Report on Identified Sustainability Information in Reliance Industries Limited's Integrated Annual Report

To the Board of Directors of RELIANCE INDUSTRIES LIMITED

1. We have undertaken to perform assurance engagement, for RELIANCE INDUSTRIES LIMITED (the "Company") vide our engagement letter dated December 23, 2024, in respect of the agreed Sustainability Information listed below (the "Identified Sustainability Information") in accordance with the criteria stated in paragraph 3 below. This Sustainability Information is included in the Integrated Annual Report (the "IAR" or the "Report") of the Company for the year ended March 31, 2025. This engagement was conducted by our multidisciplinary team including assurance practitioners, environment engineers and specialists.

2. Identified Sustainability Information

Our scope of reasonable and limited assurance consists of the Sustainability Information listed in Appendix I and Appendix II respectively to our report. The reporting boundary of the Report is disclosed in the 'Integrated Approach to Sustainable Growth' section in IAR with exceptions disclosed by way of note under respective disclosures, where applicable.

3. Criteria

The Criteria used by the Company to prepare the Identified Sustainability Information is with reference to GRI Sustainability Reporting Standards, issued by the Global Reporting Initiative (the "GRI") referred to as the GRI Standards.

4. Management's Responsibility

The Company's management is responsible for the selection of operations, locations and its group companies forming part of the reporting boundary of the Sustainability Information included in the Report. Further, the Company's management is responsible for selecting or establishing suitable criteria for preparing the Sustainability Information, taking into account applicable laws and regulations, if any, related to reporting on the Sustainability Information, identification of key aspects, engagement with stakeholders, content, preparation and presentation of the Identified Sustainability Information in accordance with the Criteria. This responsibility includes design, implementation and maintenance of internal controls relevant to the preparation of the Report and the measurement of Identified Sustainability Information, which is free from material misstatement, whether due to fraud or error.

5. Inherent limitations

The absence of a significant body of established practice on which to draw to evaluate and measure non-financial information allows for different, but acceptable, measures and measurement techniques and can affect comparability between companies.

6. Our Independence and Quality Control

We have maintained our independence and confirm that we have met the requirements of the Code of Ethics issued by the Institute

of Chartered Accountants of India (the "ICAI") and have the required competencies and experience to conduct this assurance engagement.

We apply Standard on Quality Control ("SQC") 1, "Quality Control for Firms that Perform Audits and Reviews of Historical Financial Information, and Other Assurance and Related Services Engagements", and accordingly maintains a comprehensive system of quality control including documented policies and procedures regarding compliance with ethical requirements, professional standards, and applicable legal and regulatory requirements.

7. Our Responsibility

Our responsibility is to express a reasonable assurance opinion and limited assurance conclusion on the Identified Sustainability Information listed in Appendix I and Appendix II respectively based on the procedures we have performed and evidence we have obtained.

We conducted our engagement in accordance with the Standard on Sustainability Assurance Engagements (SSAE) 3000, "Assurance Engagements on Sustainability Information", and Standard on Assurance Engagements (SAE) 3410 Assurance Engagements on Greenhouse Gas Statements (together the "Standards"), both issued by the Sustainability Reporting Standards Board (the "SRSB") of the ICAI.

These standards require that we plan and perform our engagement to obtain reasonable assurance about whether the Identified Sustainability Information listed in Appendix I and included in

the Report are prepared, in all material respects, in accordance with the Criteria; and obtain limited assurance about whether the Identified Sustainability Information listed in Appendix II and included in the Report is free from material misstatement.

As part of both reasonable and limited assurance engagement in accordance with the Standards, we exercise professional judgement and maintain professional skepticism throughout the engagement.

8. Reasonable Assurance

A reasonable assurance engagement involves identifying and assessing the risks of material misstatement of the Identified Sustainability Information whether due to fraud or error, responding to the assessed risks as necessary in the circumstances.

The procedures we performed were based on our professional judgement and included inquiries, observation of processes performed, inspection of documents, evaluating the appropriateness of quantification methods and reporting policies, analytical procedures and agreeing or reconciling with underlying records.

Given the circumstances of the engagement, in performing the procedures listed above, we:

- Obtained an understanding of the Identified Sustainability Information and related disclosures;
- Obtained an understanding of the assessment criteria and their suitability for the evaluation and/or measurements of the Identified Sustainability Information;
- Made inquiries of Company's management, including the sustainability team, the environment team, the energy team, the compliance team, the human resource team, amongst others and those with the

responsibility for preparation of the Report;

- Obtained an understanding and performed an evaluation of the design of the key systems, processes and controls for recording, processing and reporting on the Identified Sustainability Information at the corporate office and at other plants/offices on a sample basis. This included evaluating the design of those controls relevant to the engagement and determining whether they have been implemented by performing procedures in addition to inquiry of the personnel responsible for the Identified Sustainability Information;
- Based on the above understanding and the risks that the Identified Sustainability Information may be materially misstated, determined the nature, timing and extent of further procedures;
- Tested the key assumptions, emission factors and methodologies used for calculation of GHG emissions;
- Tested the Company's process for collating the sustainability information through agreeing or reconciling the Identified Sustainability Information with the underlying records on a sample basis; and
- Tested the consolidation for various plants and offices on sample basis under the reporting boundary for ensuring the completeness of data being reported.

We believe that the evidence we have obtained is sufficient and appropriate to provide a basis for our reasonable assurance opinion.

9. Limited Assurance

A limited assurance engagement involves assessing the suitability in the circumstances of the Company's use of the Criteria as the basis for the preparation of the Identified Sustainability Information as listed in Appendix II, assessing the risks of material

misstatement of the Identified Sustainability Information whether due to fraud or error, responding to the assessed risks as necessary in the circumstances, and evaluating the overall presentation of the Identified Sustainability Information.

A limited assurance engagement is substantially less in scope than a reasonable assurance engagement in relation to both the risk assessment procedures, including an understanding of internal controls, and the procedures performed in response to the assessed risks.

The procedures we performed were based on our professional judgement and included inquiries, observation of processes performed, inspection of documents and evaluating the appropriateness of reporting policies and agreeing with underlying records.

Given the circumstances of the engagement, in performing the procedures listed above, we:

- Obtained an understanding of the Identified Sustainability Information and related disclosures;
- Obtained an understanding of the assessment criteria and their suitability for the evaluation and/or measurements of the Identified Sustainability Information;
- Made inquiries of Company's management, including the sustainability team, the compliance team, the human resource team, amongst others and those with the responsibility for preparation of the Report;
- Obtained an understanding of the key systems and processes for recording, processing, and reporting on the Identified Sustainability Information at the corporate office on a sample basis;
- Based on the above understanding and the risks that the Identified Sustainability Information may be materially

misstated, determined the nature, timing, and extent of further procedures; and

- Reviewed the Company's process for collating the sustainability information through agreeing or reconciling the Identified Sustainability Information with the underlying records on a sample basis.

We believe that the evidence we have obtained is sufficient and appropriate to provide a basis for our limited assurance conclusion.

10. Exclusions

Our assurance scope excludes the following and therefore we do not express opinion/conclusion on:

- Operations of the Company other than the Boundary covered in the Identified Sustainability Information listed in Appendix I and Appendix II;
- Aspects of the Report and the data/information (qualitative or quantitative) other than the Identified Sustainability Information; and
- The statements that describe expression of opinion, belief, aspiration, expectation, aim, or future intentions provided by the Company.

11. Other information

The Company's management is responsible for the other information. The other information comprises the information included within the IAR, other than Identified Sustainability Information and our independent assurance report dated July 24, 2025, thereon.

Our reasonable assurance opinion on the Identified Sustainability Information does not cover the other information and we do not express any form of assurance thereon.

In connection with our assurance engagement of the Identified Sustainability Information, our responsibility is to read the other information and, in doing so, consider whether the

other information is materially inconsistent with the Identified Sustainability Information or otherwise appears to be materially misstated.

If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact. We have nothing to report in this regard.

12. Reasonable Assurance Opinion and Limited Assurance Conclusion

Reasonable Assurance Opinion

Outstanding Global Depository Receipts (GDRs)/Warrants and Convertible Bonds, Conversion Date and Likely Impact on Equity

GDRs: Outstanding GDRs as on March 31, 2025 represent 26,98,06,428 equity shares constituting 1.99% of Company's paid-up equity share capital. Each GDR

represents four underlying equity shares in the Company. GDR is not a specific time-bound instrument and can be surrendered at any time and converted into the underlying equity shares in the Company. The shares so released in favour of the investors upon surrender of GDRs can either be held by investors concerned in their name or sold in the Indian secondary markets for cash. To the extent of shares so sold in Indian markets, GDRs can be reissued under the available headroom.

There are no outstanding warrants or convertible bonds having any impact on equity.

RIL GDR Programme

The Global Depository Receipts of the Company are listed on Luxembourg Stock Exchange and are traded on the International Order Book (London Stock Exchange) and amongst qualified institutional investors on the over-the-counter market in the United States of America.

RIL GDRs are exempted securities under US Securities Law. RIL GDR programme has been established under Rule 144A and Regulation S of the US Securities Act, 1933. Reporting is done under the exempted route of Rule 12g3-2(b) under the US Securities Exchange Act, 1934.

Commodity Price Risks/Foreign Exchange Risk and Hedging Activities

The Company has in place a robust risk management framework for identification and monitoring and mitigation of commodity price and foreign exchange risks. The risks are tracked and monitored on a regular basis and mitigation strategies are adopted in line with the risk management framework. For further details on the above risks, please refer the Enterprise Risk Management section of the Management Discussion and Analysis Report.

Risk Management Policy with respect to Commodities including through Hedging

Commodities Exposure

The Company is exposed to price volatility on various Petroleum, Petrochemical and other Energy related commodities, as part of its business operations. Due to the dynamic markets, prices of such Commodities fluctuate and can result in Margin Risk. This policy prescribes the guidelines for hedging Commodities Price risks.

Hedging Policy

Exposures are identified and measured across the Company so that appropriate hedging can be done on a net basis. For commodities hedging, there exist Over The Counter (OTC) and exchange markets that offer financial instruments (derivatives), that enable managing the Price risk.

Strategic decisions regarding the timing and the usage of derivatives instruments such as Swaps/Futures/Options are taken based on various factors including market conditions, physical inventories, macro-economic situation. These decisions and execution are done in line with the Board approved Commodities Risk Management Framework. The Risk Management Committee has oversight on all hedging actions taken.

More details on Risk Management are covered under the Enterprise Risk Management section of the Management Discussion and Analysis Report.

Details of non-compliance by the Company, penalties, strictures imposed on the Company by stock exchange or SEBI, or any statutory authority, on any matter related to capital markets, during the last three years

- On December 16, 2010, SEBI issued a show cause notice (SCN), inter alia to the Company (RIL) in connection with the trades by RIL in the stock exchanges in 2007 in the shares of Reliance Petroleum Limited, then a subsidiary of RIL. Hearings were held before the Whole Time Member (WTM) of SEBI in respect of the SCN. By an order dated March 24, 2017,

the WTM passed the directions: (i) prohibiting inter alia RIL from dealing in equity derivatives in the 'Futures & Options' segment of stock exchanges, directly or indirectly, for a period of one year from the date of the order; and (ii) to RIL to disgorge an amount of ₹ 447.27 crore along with interest at the rate of 12% per annum from November 29, 2007 till the date of payment. In May 2017, RIL and the other notices filed an appeal before the Securities Appellate Tribunal (SAT) against this order. SAT, by a majority order (2:1), dismissed the appeal on November 5, 2020 and directed RIL to pay the disgorged amount within sixty days from the date of the order. The appeal of RIL and other notices has been admitted by the Hon'ble Supreme Court of India. By its order dated December 17, 2020, the Hon'ble Supreme Court of India directed RIL to deposit ₹ 250 crore in the Investors' Protection Fund, subject to the final result of the appeal and stayed the recovery of the balance, inclusive of interest, pending the appeal. RIL has complied with the order dated December 17, 2020 of the Hon'ble Supreme Court of India.

In the very same matter, on November 21, 2017, SEBI issued show cause notice, inter alia, to RIL, asking RIL to show cause as to why inquiry should not be held in terms of SEBI (Procedure for Holding Inquiry and Imposing Penalties by Adjudicating Officer) Rules, 1995 and penalty not be imposed under the provisions of the Securities and Exchange Board of India Act, 1992. The Adjudicating Officer of SEBI passed an order on January 1, 2021 imposing a penalty of ₹ 25 crore on RIL. RIL paid the penalty under protest and filed an appeal before the SAT against this order. SAT has vide its order dated December 4, 2023 did not interfere with the order passed by the AO since the matter was already covered by its earlier decision dated November 5, 2020, which is in appeal by RIL before

the Hon'ble Supreme Court. RIL has filed an appeal in Hon'ble Supreme Court against Order dated December 4, 2023 of the SAT.

- ii. On December 22, 2021, SEBI issued a show cause notice inter alia to RIL asking it to show cause as to why inquiry should not be held against it in terms of SEBI (Procedure for Holding Inquiry and Imposing Penalties by Adjudicating Officer) Rules, 1995 read with Section 15I of the Securities and Exchange Board of India Act, 1992 for alleged violation of Principle No. 4 under Schedule A – Principles for Fair Disclosure of UPSI read with Regulation 8(1) of SEBI (Prohibition of Insider Trading) Regulations, 2015 read with Regulation 30(11) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015. The alleged violation, if established, will make RIL liable for monetary penalty (of not less than ₹ 1 lakh and which may extend to maximum of ₹ 1 crore) under Section 15HB of the SEBI Act, 1992. RIL filed a detailed reply to this show cause notice. The Adjudicating Officer of SEBI passed an order on June 20, 2022 imposing a penalty of ₹ 30 lakh. Appeal has been filed before the Securities Appellate Tribunal ("SAT") against this order. SAT has stayed the operation of the order dated June 20, 2022 and appeal is pending.

Material events during the year

Forfeiture and cancellation of partly paid-up equity shares

The Company cancelled 1,42,565 forfeited partly paid-up equity shares of the Company.

Bonus issue of Equity Shares

The Company declared bonus shares in the ratio of 1:1, i.e., 1 (One) new fully paid-up equity share for every 1 (One) existing fully paid-up equity share and accordingly, issued and allotted 676,61,86,449 equity shares of ₹ 10/- each.

Increase in Authorised Share Capital

The Company increased its Authorised Share Capital to ₹ 50000,00,00,000/- (Rupees Fifty Thousand Crore only) consisting of 4900,00,00,000 (Four Thousand and Nine Hundred Crore) equity shares of ₹ 10/- (Rupees Ten only) each and 100,00,00,000 (One Hundred Crore) preference shares of ₹ 10/- (Rupees Ten only) each and consequently, Clause V of the Memorandum of Association of the Company stands altered.

Reliance and Disney – Strategic Alliance

The Company completed the formation of strategic joint venture (JV) between the Company, Viacom 18 Media Private Limited (now known as Studio 18 Media Private Limited) ("Viacom18") and The Walt Disney Company ("Disney"), by the

transfer of the media and JioCinema businesses into Star India Private Limited. The JV is now a subsidiary of the Company and owned 16.34% by the Company, 46.82% by Viacom18 and 36.84% by Disney.

Management Discussion and Analysis Report

Management Discussion and Analysis Report for the year under review, as per the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations"), is presented in a separate section, which forms part of this Annual Report.

Business operations/ performance of the Company and its major subsidiaries

Major developments and business performance of the Company and its major subsidiaries consolidated with the Company are given below:

Retail

Reliance Retail delivered another year of growth led by steady performance across all consumption baskets.

The business recorded a Gross Revenue of ₹ 330,943 crore for the FY25 with a growth of 7.9% over last year. It has registered an EBITDA of ₹ 25,094 crore, growing by 8.6% Y-o-Y, driven by improved store productivity and effective cost management.

Strategic partnerships such as Shein, Asos, Delta Galil and Saks Fifth Avenue further reinforce Reliance Retail's position as the partner of choice for international brands entering India. Reliance Retail continues to be India's preferred retailer for consumer electronics, fashion & lifestyle and grocery.

Digital Services

Digital Services achieved a revenue of ₹ 1,54,119 crore driven by tariff increase in the mobility business, ramp-up of homes and enterprise services and scale up of digital platforms. The business registered an EBITDA of ₹ 65,001 crore which

was on account of higher revenue and consistent improvement in margins. Digital Services has delivered 2X growth in EBITDA over the past four years.

Jio is the largest operator globally (outside China) by 5G subscribers, with 191 million Jio True5G subscribers. JioAirFiber services has accelerated the pace of home connect and is close to global leadership in FWA with ~6 million homes. In addition, there is also strong momentum in revenue contribution from content bundling and cloud and IoT services for enterprises.

Media and Entertainment

During the year, JioStar - India's largest media platform was created by the merger of Viacom18 and Star India. It brought together iconic brands across entertainment and sports, including Colors, Star Plus, Star Gold and Star Sports and integrated JioCinema and Disney+Hotstar into a single super streaming service, JioHotstar. JioStar reinforced its pre-eminent position in the Indian television landscape with 34% viewership share across Entertainment genres. JioHotstar scaled upto 280 million paying subscribers during IPL Season 18, the second highest globally and hit peak MAUs of 503 million in March 2025. The News business restructuring was also completed with the merger of Network18 and TV18, creating India's biggest omni-channel news media powerhouse. The TV News network was No. 1 in India with leadership in national and regional markets. Moneycontrol was the undisputed leader in financial news segment. 3 movies of Jio Studio were amongst the year's top 5 Hindi hits.

Oil to Chemicals

Revenue of Oil to Chemicals for FY25 increased by 11 % Y-o-Y to ₹ 6,26,921 crore on account of higher volumes and increased domestic product placement.

EBITDA of Oil to Chemicals for FY25 was at ₹ 54,988 crore, down by 11.9%. Earnings were impacted by weak margin environment across transportation fuels and downstream chemicals. This was partially offset

by feedstock sourcing, advantageous ethane cracking.

Strong domestic demand and conducive margin environment enabled higher domestic retail fuel placement through Jio-bp during the year.

Oil & Gas

Oil & Gas segment achieved highest ever revenue and EBITDA and witnessed 3.2% Y-o-Y increase in Revenue to ₹ 25,211 crore & 4.9 % increase in EBITDA to ₹ 21,188 crore. The increase is mainly on account of higher gas and condensate production from KG-D6 and CBM Field partly offset by lower gas price realisation.

KG D6 has three producing fields namely, R-Cluster, Sat-Cluster and MJ with combined average gas production of ~28 MMSCMD and oil & condensate production of ~21,000 bbls in FY25. Development is being planned for three additional wells in R Cluster and one additional well in Satellite Cluster which is expected to provide incremental recovery of ~240 BCF from these fields. Development Plan for these additional wells is approved by the Government.

In CBM, first 40 Multi-lateral Wells (MLW) campaign has been completed. The campaign has established > 3X productivity of MLWs compared to vertical wells. Incremental production of 0.4 MMSCMD from the 40 MLWs has helped in successfully reversing the field decline. Average field production for FY 25 is ~0.8 MMSCMD. Based on the success of first MLW campaign, the Company aims to continue MLW campaigns and prepare for development of CBM (East) and accordingly, has commenced second 40 MLW campaign.

Together these fields are contributing to 30% of India's Production.

Credit Rating

The Company's financial discipline and prudence is reflected in the strong credit ratings ascribed by rating agencies. The details of credit ratings are disclosed in the Management Discussion and Analysis Report, which forms part of this Annual Report.

Consolidated Financial Statement

- re-appointment of His Excellency Yasir Othman H. Al Rumayyan as an Independent Director of the Company for a second term of 5 (five) consecutive years, i.e., upto July 18, 2029; and
- re-appointment of Shri P.M.S. Prasad as a Whole-time Director, designated as an Executive Director of the Company, for a

period of 5 (five) years, with effect from August 21, 2024.

In the opinion of the Board, Shri Haigreve Khaitan and His Excellency Yasir Othman H. Al Rumayyan possess requisite expertise, integrity, experience and proficiency.

The Board of Directors based on the recommendation of the HRNR Committee:

- approved re-appointment of Shri Hital R. Meswani as a Whole-time Director, designated as an Executive Director of the Company, for a period of 5 (five) years, with effect from August 4, 2025; and
- appointed Shri Anant M. Ambani as a Whole-time Director, designated as an Executive Director of the Company, for a period of 5 (five) years, with effect from May 1, 2025.

The Company has received declarations from all the Independent Directors of the Company confirming that:

- they meet the criteria of independence prescribed under the Act and the Listing Regulations; and
- they have registered their names in the Independent Directors' Databank.

The Company has devised, *inter alia*, the following policies viz.:

- Policy for selection of Directors and determining Directors' independence; and
- Remuneration Policy for Directors, Key Managerial Personnel and other employees.

Programme – WomenConnect Challenge India

1. Study – End-line Evaluation of WomenConnect Challenge India (Round 2)



Impact Study Agency – Population Council Consulting Private Limited

Background

The WomenConnect Challenge India programme to identify and support innovative solutions to empower women in India, for use of digital technology for positive outcomes for themselves and their families connected over one lakh women directly and 1.6 lakh individuals indirectly, across seven states and one Union Territory through seven not-for-profit organisations funded by Reliance Foundation.

Objectives

To assess women's access to varied digital tools and services, and the impact of technology use on women's economic empowerment

Key findings

Digital access: Over 97% of participants had access to a phone with over 75% owning a smartphone, and a similar proportion a mobile phone.

Digital awareness: Six out of ten participants reported knowing basic phone functions; 80% were aware of at least one risk of using the internet; 75% understood risks of digital transactions.

Shifts in digital knowledge: 83% of direct participants reported improved knowledge of phone functions over the past year. Women who owned a phone as well as younger and more educated women had greater knowledge. 60% of participants reported increase in knowledge of digital payments, while over three-fourths an increase in understanding of social media applications.

Digital use: WhatsApp, phone calling and entertainment were most common reported activities; over 80% of participants reported increase in phone usage, social media engagement and digital payments in the past year; Phone

owners had higher usage and 94% confidence in using mobile devices.

Use of phone for livelihood purposes: 60% of participants reported usage for business activities with notable rise in digital payment use.

Women Empowerment: 87% of women reported greater freedom of movement; 77% mentioned more active participation in household decision-making; 80% reported improved self-confidence, over three-fourths acknowledged increase across these empowerment dimensions.

Financial inclusion: 98% of participants hold a formal financial institution account.

Opportunities for the programme's sustainability: Robust peer-learning ecosystem, integrating digital literacy into self-help group activities, for existing community structures to sustain digital and financial literacy initiatives enabling both sustainability and scalability.

Programme: Women Empowerment

2. Study: Outcome Monitoring of Women's Economic Empowerment Programme (Swayamshree)



Impact Assessment Agency – Sambodhi Research and Communications Private Limited

Background

Reliance Foundation and the Gates Foundation's Empowering Women Entrepreneurs (EWE) Programme for 11 lakh women across Madhya Pradesh, Odisha, and Gujarat aims to enable women to earn up to ₹1 lakh annually while enhancing their income, quality of life, and decision-making power.

Objective

To assess the underlying factors influencing baseline trends in women's livelihoods and agency and document the learnings and best practices

Key findings:

Women, Livelihood, and Agency: Higher restrictions on mobility and participation in Madhya Pradesh due to social norms and domestic violence. More women in Gujarat identify as farmers than in Madhya Pradesh and Odisha.

Financial Behaviour and Digital Access: Low formal credit access, leading to informal loans, limited digital literacy, reducing uptake of digital financial tools and minimal WhatsApp use in Odisha and Gujarat.

Training and Capacity Building: Practices like multi-layer farming, home-made fertilizers, livestock training conducted.

Enterprise and Non-Timber Forest Produce (NTFP): Home-based enterprises provide secondary incomes.

Collectives: Farmer Interest Group (FIG) / Producer Group (PG) participation is higher in Madhya Pradesh and Odisha while new groups are emerging in Gujarat, but leadership in Odisha restricted to few women.

Market Linkages: With weak market connections, few women are aggregators. Increasing women aggregators and involving men in market awareness could improve income and access.

Programme – Rural Transformation

3. Study – Effectiveness of RF-RT Tollfree Helpline Service



Impact Study Agency – ImpactDash (EveryULB Technologies Private Limited)

Background

Reliance Foundation's Rural Transformation programme bridges information gaps to enhance livelihoods through knowledge on agricultural practices in 10 Indian languages, for farmers and fisherfolk. Reliance Foundation's Toll-Free Helpline offers vital services for sustainable, safer rural livelihoods.

Objectives

Assess helpline accessibility for rural users and its impact on user decision-making, adoption of recommendations by helpline, relevance of information and effectiveness in resolving user queries

Key findings

Awareness and Accessibility: 98% of respondents familiar with the service, of which 98% reported using the RF helpline as their primary source of information.

Relevance and Adequacy: 94% of respondents found the advice pertinent while 63% indicated it was clear indicating there may still be room to enhance clarity for users.

Effectiveness: 85% of respondents reported that the helpline was useful for adoption while 65% could connect to experts within two minutes with calls typically lasting more than three minutes.

Adoption and Impact: 83% of respondents stated they took actionable decisions; 89% reported adopting, and 94% of those who implemented the recommendations observed economic benefits underscoring effectiveness in driving practical, positive outcomes for its users.

Programme – Rural Transformation

4. Study – Enhancing Productivity and Income through Improved Farming Practices



Impact Study Agency – Global Tenet Events and Research

Background

The Rural Transformation Programme enhances sustainable livelihoods through an integrated approach from communities to government bodies. Interventions include promotion of climate-smart agricultural practices through integration into local planning water resource management, diversified farming systems and better market access with focus on women.

Objectives

- Assess changes in crop yield and farm income across the Kharif cropping cycle for key crops such as Paddy, Maize, Soybean, Cotton and Groundnut.

- Evaluate the extent to which improved farming practices have contributed to a reduction in cultivation costs and the influence of timely advisories on farmer decision-making

Key findings

Increase in Crop Yield and Farm Income Across Key Kharif Crops:

Productivity and income increase due to enhanced crop management and better resource utilisation were as follows:

- Increase of 32% in net income and 8.2% in productivity of paddy crop
- Increase of 7.6%, in yields and 34% in income of maize crop
- Increase of 8.8% productivity and 34% net income in soybean crop
- 7.9% increase in productivity and 26% income enhancement in cotton crop
- 11.6% productivity increase and 24% income boost in groundnut crop

Reduction in Cultivation Costs Through Improved Farming Practices:

39% of respondents attributed cost reductions, nutrition management (89%), soil and tillage improvements (71%), and better post-harvest handling (59%) with other practices.

Impact of Timely Advisories on Decision-Making, Risk Mitigation, and Loss Aversion:

Informed decisions for reduced risks and improved resilience. 69% of farmers reported avoiding agricultural losses, 60% accessed government schemes, 77% of farmers reported enhanced knowledge.

Adoption of Improved Practices by Non-Intervention Farmers:

75% of respondents observed that, on average, five other farmers adopted improved practices after witnessing positive results on their farms. 97% farmers indicated they continued these methods in the following crop season.

Additional Observation: Water Availability for Agriculture and Drinking:

Erratic rainfall, groundwater depletion, and poor drinking water quality affected farming and health. Drip irrigation, check dam construction and rainwater harvesting were positive developments. Collaborative interventions with Gram Panchayats improved safe water with potential for scale.

Programme – Rural Transformation

5. Study – Assessing Economic Impact of Livelihood-Based Advisories



Impact Study Agency – Global Tenet Events and Research

Background

The Rural Transformation Programme has reached several million people across 19 states and 2 Union Territories with a 'phygital' approach that blends digital tools with physical outreach. Address critical information asymmetries advisories via digital channels and the Machli mobile app, provide real-time information for safer, sustainable fishing and long-term economic stability.

Objectives

Evaluate the adoption and effect of advisories by both farmers and fisherman and analyse improvements such as cost savings, asset protection, increased yields, better trip planning, and overall income growth

Key findings

High Adoption Driven by Relevance and Accessibility: Over 96% of farmers and 83% of fisherfolk reported using the advisories 'sometimes' or 'frequently' on weather-based information, farm practices or safety precautions.

Transformative Shifts in Practices and Planning:

Over 70% reported adopting improved practices while over 80% fisherfolk used advisories to plan their fishing activities.

Increased crop yields (82%), reduced cost of cultivation (75%), improved animal health (45%), higher income from fishing trips (65%), better protection of nets and vessels, fewer no-catch trips (49%), and a reduction in sea-related accidents (37%) are reported outcomes.

Economic Gains Reflect Real-World Impact:

82% farmers reported increase in net income from crop production, 75% experienced reduction in cost of cultivation by 4% and enhanced crop productivity was

reported in key crops such as groundnut (13%), paddy (12%), wheat (9%), and mustard and soybean (7%).

65% fisherfolk reported economic benefits with 10.3% rise in annual wages 35% increase in net income by boat owners indicating positive financial impact.

User Feedback: 83% of farmers and 81% of fisherfolk rated the services positively preferring this information with 69% of farmers and 88% of fisherfolk passing on advisories to peers.

Programme – Early Childhood Care & Education (ECCE)

6. Study – Outcome Monitoring of ECCE (Round 1)



Impact Study Agency – Oxford Policy Management

Background

The Early Childhood Care & Education (ECCE) programme seeks to transform India's ECCE landscape by establishing Anganwadi Learning Labs (AWLLs), strengthening ICDS functionaries, and engaging communities for children aged 3-6 years to achieve developmental milestones. Implemented in Maharashtra and Telangana, in partnership with the state govt. departments. The hub and spoke model includes high dose intervention medium dose intervention in selected ICDS centres and low-dose treatment in others.

Objectives

To gather stakeholder insights on programme implementation and key inputs and analyze Baseline Data to identify best practices, challenges and opportunities.

Key findings

Capacity Building: All Anganwadi Teachers (AWTs) and supervisors attended trainings, covering ECCE concepts and development domains, with positive feedback.

Training helped AWTs enhance classroom routines. "Training on ECCE has helped me establish a structured daily routine for children, allowing me to engage them in

play-based learning through storytelling & TLMs (teaching learning material)." - AWT Group A, Maharashtra.

Classroom practices on ECCE: All AWTs provided positive feedback on the quality of TLMs, and stationery received. "Previously, children showed little engagement. With play-based activities, their participation in class has significantly increased." - AWT Group B, Telangana

Community events like ECCE Day, 'Welcome Melas' (enrolment drives through community engagement & play-based activities) have helped boost enrolment and improved parental involvement.

Parent & Community Engagement:

Regular parental engagement through parent's groups using locally contextualised digital TLMs improved children's learning at home though limited smartphone access remains a challenge.

Programme: CSR interventions at Jhajjar

7. Study: Impact Assessment of Interventions at Jhajjar



Impact Assessment Agency – Sustainable Outcomes Private Limited

Background

Reliance Foundation has developed a comprehensive approach in the Model Economic Township (MET) in Jhajjar district over the past few years for development and community well-being.

Objective

To evaluate the immediate and sustainable impact of the initiatives on healthcare, education, skill training and women empowerment, community welfare, and sports for development and their impact on the socioeconomic status of the targeted communities

Key Findings

Awareness: Strong awareness (100%) of the programme's initiatives, highlights effective outreach; health (92%) and rural infrastructure (79%).

Health: Mobile Medical Units (MMU) have enhanced doorstep delivery of primary health care in villages. General health services are reaching nearly 95% of families. SC (scheduled caste) and ST (scheduled tribe) households make up 60% of those served. Estimated net potential savings are about ₹ 1.85 crore. For every rupee spent on doorstep health care, there is a social benefit by a multiple of 4.34.

RF's strategic partnerships with public hospital such as Bahadurgarh Civil Hospital, have led to 46% of the beneficiaries accessing free spectacles or cataract surgery.

907 beneficiaries (94.5% of estimated affected women) were reached during 2022-23. For every ₹ 1 spent on the camps, an economic benefit of ₹ 19.60 was generated while every rupee spent on dental care generated a social benefit of ₹ 14 to ₹ 33.

Education : Mission Navodaya improved education outcomes. 40% of the total 80 students from the region admitted to Jawahar Navodaya Vidyalaya in 2022-23.

Skilling and women empowerment: Of 214 households surveyed, 88 had participated in various training interventions. 85% households indicated that female members were involved in skills programme. Each woman averaged ₹ 3000 monthly earnings through these trainings.

Community Welfare and Infrastructure Development: 59.35% of households used public taps and 34.11% were dependent on public borewells indicating increased awareness and trust in community-managed water supply systems. These households, now earn an additional ₹ 15,000 per month (average) from milk sales.

RF's Jhajjar sports infrastructure and improved training facilities has strengthened the region's sporting culture.

Over 75% of households hold the PM Ayushman Bharat Yojana card, under Mission Sahyog reporting a monthly benefit of ₹ 753 per household.

2500 trees planted across seven villages, with estimated 92.5% survival rate with improved air quality and reduced soil erosion.

Programme: CSR interventions at Gadimonga

8. Study: Impact Assessment Report on Findings from Community Development Programme in Gadimoga, Telangana



Impact Assessment Agency – The Institute of Public Enterprise

Background

Gadimoga, actively implemented development and sustainability initiatives in nine villages with 16,767 population to enhance the socio-economic well-being of local communities for positive impact.

Objective

To assess the socio-economic impact of programme interventions and measure the improvement in quality of life of the targeted community.

Key Findings

Education – Reliance Foundation has been distributing educational kits across schools in Gadimoga. The Dhirubhai Ambani Protsaham Scheme, enabled 95% of economically disadvantaged students to access quality education, with 25% enrolling in STEM courses. Teacher shortages, were addressed through Vidya Volunteers, reducing teaching load by 20% and providing livelihood for youth. In collaboration with Padala Charitable Trust, career counselling for high school students, helping 80% choose suitable career paths. Building of two classrooms at Zilla Parishad High School, Gadimoga, improved attendance by 90% with construction of an Anganwadi Centre. The company also upgraded government school classrooms, labs, furniture, and sanitation, improving overall learning experience. Three rural libraries through Village Knowledge Centre, support youth in exam preparation, with 25% securing jobs while Children's Day celebrations foster creativity among students.

Health - A Primary Health Centre was established and its operations funded for improved health outcomes. Eye and

general health camps, benefited 85% of villagers raising health awareness. Health programmes addressed maternal nutrition, mental health, hygiene, and adolescent reproductive health.

Rural water supply – Rural water supply system created for Tallarevu handed over to the Andhra Pradesh Rural Water Supply Department for Gadimoga, Chinavalasala, Pedavalasala, and Laxmipathipuram, Waterborne and skin diseases have reduced by 50%.

Women empowerment and skilling - Tailoring and designing training enabled 35 percent of women to earn an income and improve their family status.

Environment - Coconut saplings distributed through its Green Belt Initiative, enhanced greenery, improved air quality, and promoted environmental sustainability.

Sports and Development- A volleyball court constructed, encouraged regular attendance and active participation, leading to improved physical fitness levels among the participants.

Programme: Education-Reliance Foundation School

9. Study: Evaluation of Reliance Foundation School- Vadodara, Gujarat



Impact Assessment Agency – Sustainable Outcomes Private Limited

Background

Reliance Foundation Schools work to provide an enjoyable and enriching educational experience to children to inspire and facilitate their full potential with a fine blend of curricular and co-curricular activities.

Founded in 1989, Reliance Foundation School in Vadodara is a co-ed institution offers classes I to X in both English and Gujarati mediums with quality education encouraging students to discover and develop their unique talents.

Objective:

- To assess students' academic performance, critical thinking,

emotional well-being, and preparedness for higher education or career pathways

- To examine instructional quality, resource adequacy, key achievements, and challenges, to provide actionable insights for enhancing school programmes.

Key Findings:

Academic Performance: The RF School demonstrated improved Board Exam results across both English and Gujarati mediums, particularly in the higher score brackets. Class X results had an increase in students scoring above 80%.

Dropout Rates: The overall dropout rate at RF School (9.0%) is significantly lower than the Gujarat state average of 17.9% for secondary classes, as per the SDG India Index 2023–24 (NITI Aayog). Most dropouts are attributed to family relocation or parental job transfers, particularly in Subhanpura, Vadodara.

Extracurricular Participation: 97.5%, extracurricular participation with full participation among female students.

Teaching Quality: Teaching methods are engaging and application-oriented, supported by interactive tools though some students face challenges.

Digital Learning: Digital integration in classrooms is robust, with interactive panels, subject-specific labs, and educational tools. Students with limited prior exposure to technology tend to struggle with advanced digital content.

21st-Century Skills: While a structured digital literacy curriculum is in place, gaps in advanced areas like HTML and AI may stem from limited access to digital devices at home.

Counselling & Career Readiness: The school combines conceptual learning with career counselling, digital literacy, and exposure to industry insights to prepare students for higher education and careers in STEM.

Programme: Reliance Foundation Developmental Grants

10. Study: Impact Study of community developmental grants provided in the areas of healthcare, education, wildlife conservation, art and culture



Impact Assessment Agency – Athena Infonomics India Private Limited (AIPL)

Background

Reliance Foundation implements programmes to empower communities and driving positive transformation across healthcare, education, art and culture, and wildlife conservation. Key initiatives assessed include the Super Specialty Cardio Cath Lab at Kasturba Vaidyakiya Rahat Mandal, installation of a Smart CT Scan Machine at Nirmal Government Hospital, infrastructure expansion at Sher Singh Karki School in Uttarakhand, the development of new enclosures at Pilikula Zoological Park, the Odia Parba cultural event and Pandit Deendayal Energy University (PDEU) in Gandhinagar, Gujarat.

Objective

To evaluate the relevance, effectiveness, and impact of the community developmental projects and to understand the extent to which these interventions have contributed to the well-being of the communities/ stakeholders they serve.

Key findings

Relevance

- Most KVRM patients visited for routine check-ups (94.6%), emphasising preventive care. Smaller groups sought symptom consultations (19.6%), follow-ups (17.9%), cardiac tests (17.9%), or post-op care (14.3%). Emergency visits were minimal (3.6%).

- At Nirmal Government Hospital, 74.3% learned about CT (computed tomography) scan services via doctor referrals, with word-of-mouth (51.4%) and family/friend recommendations (34.3%).
- Students at Sher Singh Karki School in Uttarakhand appreciated the new classrooms for their spacious design, comfortable seating, and well-lit, climate-controlled environment.
- About 30.8% of zoo visitors at Pilikula Zoological Park were first-timers, 40.4% visited rarely, and 5.8% visited frequently. Education (57.7%) was the top reason, followed by recreation (26.9%) and wildlife observation/ photography (25.0%).
- The Odia Parba event attracted over 15,000 attendees, showcasing Odisha's culture through live demonstrations, performances and knowledge of Odisha's heritage.
- PDEU is home to India's first Solar PV Panel Assembly Line (SOPAL) within a university. 86.7% of students enrolled in SOPAL due to their interest in Solar PV technology, showcasing strong alignment with student aspirations.
- The Center of Next Generation Computing (CNGC), also referred to as the Apple Lab, at Pandit Deendayal Energy University (PDEU) provides students with access to advanced computing resources.

Effectiveness

- 96.4% of patients found the Cardio Cath Lab's treatment met their expectations.
- The eight new enclosures at Pilikula Zoological Park improved animal living conditions and introduced rare species. 73% of visitors gained significant wildlife knowledge, and 93% felt the new housing raised conservation awareness.
- The classrooms and facilities at Sher Singh Karki School increased student enrolment, attendance and learning conditions from 190 to 281.

- Facilities in SOPAL received overwhelmingly positive feedback. 99% of students reported all the supporting facilities at CNGC lab to be free, ensuring inclusivity and removing financial barriers.

Impact

- The Cardio Cath Lab at KVRM improved patient well-being, with 89.3% reporting better quality of life, 85.7% improved daily function, and 71.4% reduced symptoms. Smaller gains included better health awareness (39.3%), faster recovery (16.1%), and improved mental state (10.7%). 85.75% of patients received free treatment, while 7.1% paid an average of ₹16,575.
- All students at Sher Singh Karki School (100%) are happy with the new facilities, with 98.2% feeling positive. Improved concentration (53.6%), motivation (39.3%), and results (33.9%) were noted, along with increased interest in studies (73.2%), higher marks (64.3%), and better self-esteem (46.4%). Increase in participation in extracurricular activities (39.3%) and sports (35.7%).
- 71% of the Pilikula Zoological Park visitors rated their experience as "Good" or "Excellent," with the same percentage appreciating new additions. Educational programmes engaged school groups, and 50% benefited from informational boards.
- Participants at Odia Parba earned ₹18,333 per day on average; 8 saw increased customer variety, and ten were fully satisfied with networking.
- 88.6% of students felt the CNGC improved employability. 80% of students aim for careers in renewable energy. Students save an average of ₹6,907 monthly by using the CNGC. 87% of students would recommend SOPAL. 66% of students found CNGC well-equipped, requiring no extra resources.

to the Standalone Financial Statements for the year ended 31st March, 2025

A. Corporate Information

Reliance Industries Limited ("the Company") is a listed entity incorporated in India. The registered office of the Company is located at 3rd Floor, Maker Chambers IV, 222, Nariman Point, Mumbai - 400 021, India.

The Company is engaged in activities spanning across hydrocarbon exploration and production, Oil to Chemicals, Retail and Digital Services.

B. Material Accounting Policies:

B.1 Basis of Preparation and Presentation

The Financial Statements have been prepared on the historical cost basis except for following assets and liabilities which have been measured at fair value amount:

- Certain Financial Assets and Liabilities (including derivative instruments),
- Defined Benefit Plans – Plan Assets, and
- Equity settled Share Based Payments

The Financial Statements of the Company have been prepared to comply with the Indian Accounting standards ('Ind AS'), including the Rules notified under the relevant provisions of the Companies Act, 2013, (as amended from time to time) and Presentation and disclosure requirements of Division II of Schedule III to the Companies Act, 2013, (Ind AS Compliant Schedule III) as amended from time to time. The Company follows indirect method prescribed in Ind AS 7 – Statement of Cash Flows for presentation of its cash flows.

The Company's Financial Statements are presented in Indian Rupees (₹), which is also its functional currency and all values are rounded to the nearest crore (₹00,00,000), except when otherwise indicated.

B.2 Summary of Material Accounting Policies

(a) Current and Non-Current Classification

The Company presents assets and liabilities in the Balance Sheet based on Current/ Non-Current classification considering an operating cycle of 12 months being the time elapsed between deployment of resources and the realisation/ settlement in cash and cash equivalents there-against.

(b) Property, Plant and Equipment

Property, Plant and Equipment are stated at cost, net of recoverable taxes, trade discount and rebates less accumulated depreciation and impairment losses, if any. Such cost includes purchase price, borrowing cost and any cost directly attributable to bringing the assets to its working condition for its intended use, net charges on foreign exchange

contracts and adjustments arising from exchange rate variations attributable to the assets. In case of land the Company has availed fair value as deemed cost on the date of transition to Ind AS.

Other Indirect Expenses incurred relating to project, net of income earned during the project development stage prior to its intended use, are considered as pre-operative expenses and disclosed under Capital Work-in-Progress.

Depreciation on Property, Plant and Equipment is provided using written down value method on depreciable amount except in case of certain assets of Oil to Chemicals and Other segment which are depreciated using straight-line method. Depreciation is provided based on useful life of the assets as prescribed in Schedule II to the Companies Act, 2013 except in respect of the following assets, where useful life is as under:

Particular	Depreciation
Fixed Bed Catalyst (useful life: 2 years or more)	Over its useful life as technically assessed
Fixed Bed Catalyst (useful life: up to 2 years)	100% depreciated in the year of addition
Plant and Machinery (useful life: 25 to 50 years)	Over its useful life as technically assessed
Buildings (Useful life: 30 to 65 years)	Over its useful life as technically assessed

The residual values, useful lives and methods of depreciation of Property, Plant and Equipment are reviewed at each financial year end and adjusted prospectively, if appropriate.

(c) Leases

The Company, as a lessee, recognises a right-of-use asset and a lease liability for its leasing arrangements, if the contract conveys the right to control the use of an identified asset. Initially the right-of-use assets measured at cost which comprises initial cost of the lease liability adjusted for any lease payments made at or before the commencement date plus any initial direct costs incurred. Subsequently measured at cost less any accumulated depreciation/ amortisation, accumulated impairment losses, if any and adjusted for any remeasurement of the lease liability.

The right-of-use assets is depreciated/ amortised using the straight-line method from the commencement date over the shorter of lease term or useful life of right-of-use asset.

The Company measures the lease liability at the present value of the lease payments that are not paid at the commencement date of the lease. The lease payments are discounted using the

interest rate implicit in the lease, if that rate can be readily determined. If that rate cannot be readily determined, the Company uses incremental borrowing rate.

For short-term and low value leases, the Company recognises the lease payments as an operating expense on a straight-line basis over the lease term.

(d) Intangible Assets

Intangible Assets are stated at cost of acquisition net of recoverable taxes, trade discount and rebates less accumulated amortisation/depletion and impairment losses, if any. Such cost includes purchase price, borrowing costs, and any cost directly attributable to bringing the asset to its working condition for the intended use, net charges on foreign exchange contracts and adjustments arising from exchange rate variations attributable to the Intangible Assets.

Other Indirect Expenses incurred relating to project, net of income earned during the project development stage prior to its intended use, are considered as pre-operative expenses and disclosed under Intangible Assets Under Development.

The Company assesses if useful life of an intangible asset is finite or indefinite. A summary of amortisation/depletion policies applied to the Company's Intangible Assets to the extent of depreciable amount is as follows:

Particular	Amortisation / Depletion
Technical Know-How	Over the useful life of the underlying assets ranging from 5 years to 35 years.
Computer Software	Over a period of 5 years.
Development Rights	W.r.t. Oil and Gas, depleted using the unit of production method. The cost of producing wells along with its related facilities including decommissioning costs are depleted in proportion of oil and gas production achieved vis-à-vis Proved Developed Reserves. The cost for common facilities including its decommissioning costs are depleted using Proved Reserves. With respect to other development rights, these are amortised over the period of contract.
Others	In case of Jetty, the aggregate amount amortised to date is not less than the aggregate rebate availed by the Company.

The amortisation period and the amortisation method for Intangible Assets with a finite useful life are reviewed at each reporting date.

(e) Inventories

Items of inventories are measured at lower of cost and net realisable value after providing for

obsolescence, if any, except in case of by-products which are valued at net realisable value.

Cost of finished goods, work-in-progress, raw materials, chemicals, stores and spares, packing materials, trading and other products are determined on weighted average basis.

(f) Provisions

Provisions are recognised when the Company has a present obligation (legal or constructive) as a result of a past event, it is probable that an outflow of resources embodying economic benefits will be required to settle the obligation and a reliable estimate can be made of the amount of the obligation. If the effect of the time value of money is material, provisions are discounted using a current pre-tax rate that reflects, when appropriate, the risks specific to the liability. When discounting is used, the increase in the provision due to the passage of time is recognised as a finance cost.

Provision for Decommissioning Liability

The Company records a provision for decommissioning costs towards site restoration activity. Decommissioning costs are provided at the present value of future expenditure using a current pre-tax rate expected to be incurred to fulfil decommissioning obligations and are recognised as part of the cost of the underlying assets. Any change in the present value of the expenditure, other than unwinding of discount on the provision, is reflected as adjustment to the provision and the corresponding asset. The change in the provision due to the unwinding of discount is recognised in the Statement of Profit and Loss.

(g) Contingent Liabilities

Disclosure of contingent liability is made when there is a possible obligation arising from past events, the existence of which will be confirmed only by the occurrence or non-occurrence of one or more uncertain future events not wholly within the control of the Company or a present obligation that arises from past events where it is either not probable that an outflow of resources embodying economic benefits will be required to settle or a reliable estimate of amount cannot be made.

(h) Current Tax and Deferred Tax

The tax expenses for the period comprise of current tax and deferred tax. The Company exercises judgment in computation of current tax considering the relevant rulings and reassesses the carrying amount of deferred tax assets at the end of each reporting period.

(i) Share Based Payments

In case of Group equity-settled share-based payment transactions, where the Company grants stock options to the employees of its subsidiaries, the transactions are accounted by increasing the cost of investment in subsidiary with a corresponding credit in the equity.

(j) Foreign Currencies Transactions and Translation

Exchange gains or losses on foreign currency borrowings taken prior to April 1, 2016 which are related to the acquisition or construction of qualifying assets are adjusted in the carrying cost of such assets.

(k) Revenue Recognition

Revenue from contracts with customers is recognised when control of the goods or services are transferred to the customer at an amount that reflects the consideration entitled in exchange for those goods or services. The Company is generally the principal as it typically controls the goods or services before transferring them to the customer.

Revenue is measured at the amount of consideration which the Company expects to be entitled to in exchange for transferring distinct goods or services to a customer as specified in the contract, excluding amounts collected on behalf of third parties (for example taxes and duties collected on behalf of the government). Consideration is generally due upon satisfaction of performance obligations and a receivable is recognised when it becomes unconditional.

Generally, the credit period varies between 0-60 days from the shipment or delivery of goods or completion of services as the case may be. The Company provides volume rebates to certain customers once the quantity of products purchased during the period exceeds a threshold specified and also accrues discounts to certain customers based on customary business practices which is derived on the basis of crude price volatility and various market demand – supply situations. Consideration are determined based on its most likely amount. Generally, sales of petroleum products contain provisional pricing features where revenue is initially recognised based on provisional price. Difference between final settlement price and provisional price is recognised subsequently.

(l) Financial Instruments

i. Financial Assets

Purchase and sale of Financial Assets are recognised using trade date accounting. Trade receivables that do not contain a significant financing component are measured at transaction price.

The Company has elected to account for its investments in subsidiaries, associates and joint venture at cost less impairment loss (if any).

All other equity investments are measured at fair value, with value changes recognised in Statement of Profit and Loss, except for those equity investments for which the Company has elected to present the value changes in 'Other Comprehensive Income'. However, dividend on such equity investments are recognised in Statement of Profit and loss when the Company's right to receive payment is established. The investments in preference shares with the right to surplus assets which are in nature of equity in accordance with Ind AS 32 are treated as separate category of investment and measured at Fair Value Through Other Comprehensive Income (FVTOCI). Other Financial Assets are generally measured at Fair Value Through Profit or Loss (FVTPL) except where the Company, based on the business model objectives, measures these at Amortised Cost or Fair Value Through Other Comprehensive Income (FVTOCI).

The Company uses 'Expected Credit Loss' (ECL) model, for evaluating impairment of Financial Assets other than those measured at FVTPL.

Expected Credit Losses are measured through a loss allowance at an amount equal to:

- The 12-months expected credit losses (expected credit losses that result from those default events on the financial instrument that are possible within 12 months after the reporting date); or
- Full lifetime expected credit losses (expected credit losses that result from all possible default events over the life of the financial instrument).

For Trade Receivables, the Company applies 'simplified approach' which requires expected lifetime losses to be recognised from initial recognition of the receivables.

The Company uses historical default rates to determine impairment loss on the portfolio of trade receivables. At every reporting date these historical default rates are reviewed and changes in the forward-looking estimates are analysed.

For other assets, the Company uses 12 month ECL to provide for impairment loss where there is no significant increase in credit risk. If there is significant increase in credit risk full lifetime ECL is used.

ii. Financial Liabilities

For trade and other payables maturing within one year from the balance sheet date, the carrying amounts are determined to approximate fair value due to the short maturity of these instruments.

iii. Derivative Financial Instruments and Hedge Accounting

The Company uses various derivative financial instruments such as interest rate swaps, currency swaps, forwards & options and commodity contracts to mitigate the risk of changes in interest rates, exchange rates and commodity prices. At the inception of a hedge relationship, the Company formally designates and documents the hedge relationship to which the Company wishes to apply hedge accounting and the risk management objective and strategy for undertaking the hedge.

Any gains or losses arising from changes in the fair value of derivatives are taken directly to Statement of Profit and Loss, except for the effective portion of cash flow hedge which is recognised in Other Comprehensive Income and later to Statement of Profit and Loss when the hedged item affects profit or loss or is treated as basis adjustment if a hedged forecast transaction subsequently results in the recognition of a Non-Financial Assets or Non-Financial liability.

Hedges that meet the criteria for hedge accounting are accounted for as follows:

A. Cash Flow Hedge

The Company designates derivative contracts or non-derivative Financial Assets/ Liabilities as hedging instruments to mitigate the risk of movement in interest rates and foreign exchange rates for foreign exchange exposure on highly probable future cash flows attributable to a recognised asset or liability or forecast cash transactions.

B. Fair Value Hedge

The Company designates derivative contracts or non-derivative Financial Assets/Liabilities as hedging instruments to mitigate the risk of change in fair value of hedged item due to movement in interest rates, foreign exchange rates and commodity prices.

iv. Offsetting

Financial Assets and Financial Liabilities are offset and the net amount is presented in the balance sheet when, and only when, the Company has a legally enforceable right to set off the amount and it intends, either to settle them on a net basis or to realise the asset and settle the liability simultaneously.

(m) Accounting for Oil and Gas Activity

Oil and Gas Joint Arrangement are in the nature of joint operations. Accordingly, assets and liabilities as well as income and expenditure are accounted on the basis of available information on a line-by-line basis with similar items in the Company's Financial Statements, according to the participating interest of the Company.

The Company follows the Guidance Note on Accounting for Oil and Gas producing activities – Ind AS issued by the Institute of Chartered Accountants of India for the purposes of the accounting. Seismic costs, geological and geophysical studies, petroleum exploration license fees and general and administration costs directly attributable to exploration and evaluation activities are expensed off. The costs incurred on acquisition of interest in oil and gas blocks and on exploration and evaluation other than those which are expensed off are accounted for as Intangible Assets Under Development. All development costs incurred in respect of proved reserves are also capitalised under Intangible Assets Under Development. Once a well is ready to commence commercial production, the costs accumulated in Intangible Assets Under Development are classified as Intangible Assets corresponding to proved developed oil and gas reserves. The exploration and evaluation expenditure which does not result in discovery of proved oil and gas reserves and all cost pertaining to production are charged to the Statement of Profit and Loss.

The Company uses technical estimation of reserves as per the Petroleum Resources Management System guidelines 2011 and standard geological and reservoir engineering methods. The reserve review and evaluation is carried out annually.

C. Critical Accounting Judgements and Key Sources of Estimation Uncertainty

The preparation of the Company's Financial Statements requires management to make judgement, estimates and assumptions that affect the reported amount of revenue, expenses, assets and liabilities and the accompanying disclosures. Uncertainty about these assumptions and estimates could result in outcomes that require a material adjustment to the carrying amount of assets or liabilities affected in next financial years.

(A) Estimation of Oil and Gas Reserves

The determination of the Company's estimated oil and natural gas reserves requires significant judgements and estimates to be applied and these are regularly reviewed and updated. Factors such as the availability of geological and engineering data, reservoir performance data, acquisition and divestment activity, drilling of new wells, and commodity prices all impact on the determination of the Company's estimates of its oil and natural gas reserves. The Company bases its proved reserves estimates on the requirement of reasonable certainty with rigorous technical and commercial assessments based on conventional industry practice and regulatory requirements.

Estimates of oil and natural gas reserves are used to calculate depletion charges for the Company's oil and gas properties. The impact of changes in estimated proved reserves is dealt with prospectively by amortising the remaining carrying value of the asset over the expected future production. Oil and natural gas reserves also have a direct impact on the assessment of the recoverability of asset carrying values reported in the Financial Statements.

Details on proved reserves and production both on product and geographical basis are provided in Note 33.2.

(B) Property Plant and Equipment/ Intangible Assets

Estimates are involved in determining the cost attributable to bringing the assets to the location and condition necessary for it to be capable of operating in the manner intended by the management. Property, Plant and Equipment/Intangible Assets are depreciated/ amortised over their estimated useful life, after taking

into account estimated residual value. Management reviews the estimated useful life and residual values of the assets annually in order to determine the amount of depreciation/ amortisation to be recorded during any reporting period. The useful life and residual values are based on the Company's historical experience with similar assets and take into account anticipated technological and future risks. The depreciation/ amortisation for future periods is revised if there are significant changes from previous estimates.

(C) Provisions

The timing of recognition and quantification of the liability (including litigations) requires the application of judgement to existing facts and circumstances, which can be subject to change. The carrying amounts of provisions and liabilities are reviewed regularly and revised to take account of changing facts and circumstances.

(D) Impairment of Financial and Non-Financial Assets

The impairment provisions for Financial Assets are based on assumptions about risk of default and expected cash loss rates. The Company uses judgement in making these assumptions and selecting the inputs to the impairment calculation, based on Company's past history, existing market conditions as well as forward-looking estimates at the end of each reporting period.

In case of non-financial assets, assessment of impairment indicators involves consideration of future risks. Further, the Company estimates asset's recoverable amount, which is higher of an asset's or Cash Generating Units (CGU's) fair value less costs of disposal and its value in use.

In assessing value in use, the estimated future cash flows are discounted to their present value using pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. In determining fair value less costs of disposal, recent market transactions are taken into account, if no such transactions can be identified, an appropriate valuation model is used.

The reserve estimates for producing fields are revised based on the performance of producing fields and with respect to discovered fields, the revision are based on the revised geological and reservoir simulation studies.

33.3 The Government of India ("GoI"), disallowed certain costs which the Production Sharing Contract ("PSC"), relating to Block KG-DWN-98/3 ("KG D6") entitles the Company to recover. The Company maintains that the Contractor is entitled to recover all of its costs under the terms of the PSC and there are no provisions that entitle the GoI to disallow the recovery of any Contract Cost. The Company referred the issue to arbitration with GoI for resolution of disputes. The matter is presently at the stage of Final Hearing as part of arbitration proceedings. The demand from the GoI of \$ 165 million (for ₹ 1,407 crore) being the Company's share (total demand \$ 247 million – ₹ 2,111 crore) towards additional Profit Petroleum has been considered as contingent liability as on 31st March 2025.

In supersession of the Ministry's Gazette notification no. 22011/3/2012-ONG.D.V. dated 10th January 2014, the GoI notified the New Domestic Natural Gas Pricing Guidelines, 2014 on 26th October 2014. The GoI had directed the Company to instruct customers to deposit differential revenue on gas sales from D1D3 field on account of the prices determined under the guidelines converted to NCV basis and the prevailing price prior to 1st November 2014 (\$ 4.205 per MMBTU) to be credited to the gas pool account maintained by GAIL (India) Limited. The amount so deposited by customer to Gas Pool Account is ₹ 295 crore (net) as at 31st March 2025. Revenue has been recognised at the GoI notified prices on GCV basis, in respect of gas quantities sold from D1D3 field from 1st November 2014. This amount in the Gas Pool Account has also been challenged under cost recovery arbitration and is pending adjudication.

33.4 (a) Government of India ("GoI") sent a demand notice to the KG D6 block contractor (RIL, BP Exploration (Alpha) Limited and Niko (NECO) Limited) (together "Contractor") on 3rd November 2016, on account of production of gas allegedly migrated from ONGC's blocks. RIL, as operator and on behalf of the Contractor, initiated arbitration proceedings against the GoI. The Arbitral Tribunal vide its Final Award dated 24th July 2018 ("Arbitration Award"), upheld Contractor's claims. Vide Judgment dated 9th May 2023, a single judge of the Hon'ble Delhi High Court upheld the Arbitration Award and dismissed GoI's appeal challenging the award. On an appeal by GoI, vide judgment dated 14th February 2025, the Division Bench of the Hon'ble Delhi High Court allowed GoI's appeal and set aside the judgment of the single judge and the Arbitration Award.

A demand letter dated 1st March 2025 for payment of \$ 2.81 billion (RIL share \$ 1.87 billion) was sent by GoI to the Contractor. RIL, on 17th March 2025, responded that it is not liable to make any payment to GoI and that the demand letter is without any factual or legal basis and is liable to be withdrawn. RIL will be filing an appeal against the judgement of the Division Bench of the Hon'ble Delhi High Court.

(b) Arbitration was initiated by BG Exploration and Production India Limited and the Company (together the Claimants) against GoI under the PSCs for Panna – Mukta and Tapti blocks due to difference in interpretation of certain PSC provisions between Claimants and GoI. The Arbitration Tribunal has issued a number of final partial awards in this matter, some of which have (in part) not been in Claimant's favour. The arbitration is ongoing and a final award is yet to be issued. The arbitration has also led to satellite litigation in India (presently ongoing) and in the UK, which has resulted in court judgements that have not always been entirely in RIL's favour.

(c) NTPC filed suit in 2006 for specific performance of contract for supply of natural gas of 132 trillion BTU annually for a period of 17 years. This suit is still pending adjudication in the Bombay High Court and the Company's fact witnesses in the suit are to be cross examined by NTPC. On 2nd December 2024, an SLP was filed by RIL before the Supreme Court against an Order of the Bombay High Court in the NTPC suit, directing redaction of certain portions of RIL's Affidavit. The matter is presently sub-judice.

Considering the complexity of above issues, the Company is of the view that any attempt for quantification of possible exposure to the Company will have an effect of prejudicing Company's legal position in the ongoing arbitration/ litigations. Moreover, the Company considers above demand/disputes as remote.

(III) The Income-Tax Assessments of the Company have been completed up to Assessment Year 2021-22. The total outstanding demand is ₹ 387 crore as on date. Based on the decisions of the Appellate authorities and the interpretations of other relevant provisions of the Income tax Act, 1961, the Company has been legally advised that the demand raised is likely to be either deleted or substantially reduced and accordingly no provision is considered necessary.

(IV) On December 16, 2010, the Securities and Exchange Board of India (SEBI) issued a show cause notice ("SCN") inter alia to the Company (RIL) in connection with the trades by RIL in the stock exchanges in 2007 in the shares of Reliance Petroleum Limited, then a subsidiary of RIL. By an order dated March 24, 2017, the Whole Time Member ("WTM") passed directions: (i) prohibiting inter alia RIL from dealing in equity derivatives in the 'Futures & Options' segment of stock exchanges, directly or indirectly, for a period of one year from the date of the order; and (ii) to disgorge from RIL an amount of ₹ 447 crore along with interest at the rate of 12% per annum from November 29, 2007, till the date of payment. On an appeal by RIL, Securities Appellate Tribunal ("SAT") by a majority order (2:1), dismissed the appeal on November 5, 2020, and directed RIL to pay the disgorged amount within sixty days from the date of the order. The appeal of RIL and others has been admitted by the Hon'ble Supreme Court of India. By its order dated December 17, 2020, the Hon'ble Supreme Court of India directed RIL to deposit ₹ 250 crore in the Investors' Protection Fund, subject to the final result of the appeal and stayed the recovery of the balance, inclusive of interest, pending the appeal. RIL has complied with the order dated December 17, 2020, of the Hon'ble Supreme Court of India.

In the above matter, the adjudicating officer of SEBI ("AO") while adjudicating the show cause notice dated November 21, 2017 issued, inter alia, to RIL passed an order on January 1, 2021 imposing a penalty of ₹ 25 crore on RIL. In the appeal filed by RIL, the Hon'ble Securities Appellate Tribunal vide order dated December 4, 2023, did not interfere with the order passed by the AO since the matter was already covered by its earlier decision dated November 5, 2020, which is in appeal by RIL before the Hon'ble Supreme Court. RIL has filed an appeal in the Hon'ble Supreme Court of India against Order dated December 4, 2023 of SAT. The Company continues to consider the aforesaid liability as contingent.

35. Capital Management

The Company adheres to a disciplined Capital Management framework in order to maintain a strong balance sheet. The main objectives are as follows:

- Maintain AAA rating domestically and investment grade rating internationally.
- Manage foreign exchange, interest rates and commodity price risk, and minimise the impact of market volatility on earnings.
- Diversify sources of financing and spread the maturity across tenure buckets in order to manage liquidity risk.
- Leverage optimally in order to maximise shareholder returns.

f) The fair value for level 3 instruments is valued using inputs based on information about market participants assumptions and other data that are available.

g) The fair value of the remaining financial instruments is determined using discounted cash flow analysis.

h) All foreign currency denominated assets and liabilities are translated using exchange rate at reporting date.

B. Financial Risk Management

The Company's activities expose it to variety of financial risks: market risk (including foreign currency risk and interest rate risk), commodity price risk, credit risk and liquidity risk. Within the boundaries of approved Risk Management Policy framework, the Company uses derivative instruments to manage the volatility of financial markets and minimise the adverse impact on its financial performance.

i) Market Risk

Market risk is the risk that the fair value of future cash flows of a financial instrument will fluctuate because of changes in market prices. Market risk comprises three types of risk: interest rate risk, currency risk and other price risk, such as equity price risk and commodity risk.

a) Foreign Currency Risk

Foreign currency risk is the risk that the Fair Value or Future Cash Flows of an exposure will fluctuate because of changes in foreign currency rates. Exposures can arise on account of the various assets and liabilities which are denominated in currencies other than Indian Rupee.

Commodity price risk arises due to fluctuation in prices of crude oil, other feed stock and products. The company has a risk management framework aimed at prudently managing the risk arising from the volatility in commodity prices and freight costs.

The Company's commodity risk is managed centrally through well-established trading operations and control processes. In accordance with the risk management policy, the Company enters into various transactions using derivatives and uses over-the-counter as well as Exchange Traded Futures, Options and Swap contracts to hedge its commodity and freight exposure.

iii) Credit Risk

Credit risk is the risk that a customer or counterparty to a financial instrument fails to perform or pay the amounts due causing financial loss to the Company. Credit risk arises from company's activities in investments, dealing in derivatives and receivables from customers. The Company ensure that sales of products are made to customers with appropriate creditworthiness. Investment and other market exposures are managed against counterparty exposure limits. Credit information is regularly shared between businesses and finance function, with a framework in place to quickly identify and respond to cases of credit deterioration.

The company has a prudent and conservative process for managing its credit risk arising in the course of its business activities. Credit risk is actively managed through Letters of Credit, Bank Guarantees, Parent Company Guarantees, advance payments and factoring & forfaiting without recourse to the Company to avoid concentration of risk. The company restricts its fixed income investments to liquid securities carrying high credit rating.

iv) Liquidity Risk

Liquidity risk arises from the Company's inability to meet its cash flow commitments on the due date. The company maintains sufficient stock of cash, marketable securities and committed credit facilities. The company accesses global and local financial markets to meet its liquidity requirements. It uses a range of products and a mix of currencies to ensure efficient funding from across well-diversified markets and investor pools. Treasury monitors rolling forecasts of the Company's cash flow position and ensures that the Company is able to meet its financial obligation at all times including contingencies.

The Company's liquidity is managed centrally with operating units forecasting their cash and liquidity requirements. Treasury pools the cash surpluses from across the different operating units and then arranges to either fund the net deficit or invest the net surplus in a range of short-dated, secure and liquid instruments including short-term bank deposits, money market funds, reverse repos and similar instruments. The portfolio of these investments is diversified to avoid concentration risk in any one instrument or counterparty.

C. Hedge Accounting

The Company's business objective includes safe-guarding its earnings against adverse price movements of crude oil and other feedstock, refined products, freight costs as well as foreign exchange and interest rates. The Company has adopted a structured risk management policy to hedge all these risks within an acceptable risk limit and an approved hedge accounting framework which allows for Fair Value and Cash Flow hedges. Hedging instruments include exchange traded futures and options, over-the-counter swaps, forwards and options as well as non-derivative instruments to achieve this objective.

There is an economic relationship between the hedged items and the hedging instruments. The Company has established a hedge ratio of 1:1 for the hedging relationships. To test the hedge effectiveness, the Company uses the hypothetical derivative method and critical term matching method.

The hedge ineffectiveness can arise from:

- Differences in the timing of the cash flows.
- Different indexes (and accordingly different curves).
- The counterparties' credit risk differently impacting the fair value movements.

The respective Board of Directors of the companies included in the Group and of its associates and joint ventures are responsible for maintenance of adequate accounting records in accordance with the provisions of the Act for safeguarding the assets of the Group and its associates and its joint ventures and for preventing and detecting frauds and other irregularities; selection and application of appropriate accounting policies; making judgements and estimates that are reasonable and prudent; and design, implementation and maintenance of adequate internal financial controls, that were operating effectively for ensuring the accuracy and completeness of the accounting records, relevant to

the preparation and presentation of the financial statements that give a true and fair view and are free from material misstatement, whether due to fraud or error, which have been used for the purpose of preparation of the Consolidated Financial Statements by the Board of Directors of the Parent, as aforesaid.

In preparing the Consolidated Financial Statements, the respective Management and Board of Directors of the companies included in the Group and of its associates and joint ventures are responsible for assessing the ability of the respective entities to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the respective Board of Directors either intend to liquidate their respective entities or to cease operations, or has no realistic alternative but to do so.

The respective Board of Directors of the companies included in the Group and of its associates and joint ventures are also responsible for overseeing the financial reporting process of the Group and of its associates and joint ventures.

Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these Consolidated Financial Statements.

For the other entities or business activities included in the Consolidated Financial Statements, which have been audited by the other auditors, such other auditors remain responsible for the direction, supervision and performance of the audits carried out by them. We remain solely responsible for our audit opinion.

Materiality is the magnitude of misstatements in the Consolidated Financial Statements that, individually or in aggregate, makes it probable that the economic decisions of a reasonably knowledgeable user of the Consolidated Financial Statements may be influenced. We consider quantitative materiality and qualitative factors (i) in planning the scope of our audit work and in evaluating the results of our work; and (ii) to evaluate the effect of any identified misstatements in the Consolidated Financial Statements.

We communicate with those charged with governance of the Parent and such other entities included in the Consolidated Financial Statements of which we are the independent auditors regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal financial controls with reference to financial statements that we identify during our audit.

We also provide those charged with governance with a statement that we have complied with relevant ethical

requirements regarding independence, and to communicate with them all relationships and other matters that may reasonably be thought to bear on our independence, and where applicable, related safeguards.

From the matters communicated with those charged with governance, we determine those matters that were of most significance in the audit of the Consolidated Financial Statements of the current period and are therefore the key audit matters. We describe these matters in our auditor's report unless law or regulation precludes public disclosure about the matter or when, in extremely rare circumstances, we determine that a matter should not be communicated in our report because the adverse consequences of doing so would reasonably be expected to outweigh the public interest benefits of such communication.

Other Matters

- The Consolidated Financial Statements include the financial statements / financial information of 217 subsidiaries, whose audited standalone / consolidated financial statements / financial information reflect total assets of ₹ 659,588 crore as at 31st March, 2025, total revenues of ₹ 655,163 crore and net cash outflows amounting to ₹ 6,179 crore for the year ended on that date. The Consolidated Financial Statements also include the Group's share of net profit of ₹ 195 crore for the year ended 31st March, 2025, as considered in the Consolidated Financial Statements, in respect of 12 associates and 10 joint ventures. These financial statements / financial information have been audited by one of us either individually or jointly with other auditors.
- We did not audit the financial statements / financial information of 128 subsidiaries, whose standalone / consolidated financial statements / financial information reflect total assets of ₹ 900,522 crore as at 31st March, 2025, total revenues of ₹ 497,946 crore and net cash inflows amounting to ₹ 10,302 crore for the year ended on that date, as considered in the Consolidated Financial Statements. The Consolidated Financial Statements also include the Group's share of net profit of ₹ 162 crore for the year ended 31st March, 2025, as considered in the Consolidated Financial Statements, in respect of 78 associates and 27 joint ventures, whose financial statements / financial information have not been audited by us. These financial statements / financial information have been audited by other auditors whose reports have been furnished to us by the Management and our opinion on the Consolidated Financial Statements, in so far as it relates to the amounts and disclosures included in respect of these subsidiaries, joint ventures and associates, and our report in terms of sub-section (3) of Section 143 of the Act, in so far as it relates to the aforesaid subsidiaries, joint ventures and associates is based solely on the reports of the other auditors.

(c) The Consolidated Financial Statements also include the Group's share of net profit of ₹ 165 crore for the year ended 31st March, 2025, as considered in the Consolidated Financial Statements, in respect of 28 associates and 13 joint ventures, whose financial statements / financial information have not been audited by us. These financial statements / financial information are unaudited and have been furnished to us by the Management and our opinion on the Consolidated Financial Statements, in so far as it relates to the amounts and disclosures included in respect of these joint ventures and associates, is based solely on such unaudited financial statements / financial information. In our opinion and according to the information and explanations given to us by the Management, these financial statements / financial information are not material to the Group.

Our opinion on the Consolidated Financial Statements above and our report on Other Legal and Regulatory Requirements below, is not modified in respect of the above matters with respect to our reliance on the work done and the reports of the other auditors and the financial statements / financial information certified by the Management.

Report on Other Legal and Regulatory Requirements

a) We have sought and obtained all the information and explanations which to the best of our knowledge and belief were necessary for the purposes of our audit of the aforesaid Consolidated Financial Statements.

b) In our opinion, proper books of account as required by law maintained by the Group, its associates and joint ventures including relevant records relating to preparation of the aforesaid Consolidated Financial Statements have been kept so far as it appears from our examination of those books and the reports of the other auditors, except (a) in respect of 1 acquired subsidiary company and certain branches of an associate company for not keeping backup on a daily basis of certain books of account maintained in electronic mode in servers physically located in India, and in respect of 4 joint venture companies, in the absence of independent auditor's report in relation to accounting software operated by a third party software service provider, the other auditor is unable to comment whether the back-up of the books of account maintained in electronic mode in servers physically located in India has been kept

on a daily basis during 1st February, 2025 till 31st March, 2025 and (b) in relation to compliance with the requirements of audit trail, refer paragraph (i) (vi) below.

- c) The Consolidated Balance Sheet, the Consolidated Statement of Profit and Loss including Other Comprehensive Loss, the Consolidated Statement of Cash Flows and the Consolidated Statement of Changes in Equity dealt with by this Report are in agreement with the relevant books of account maintained for the purpose of preparation of the Consolidated Financial Statements.
- d) In our opinion, the aforesaid Consolidated Financial Statements comply with the Ind AS specified under Section 133 of the Act.
- e) On the basis of the written representations received from the directors of the Parent as on 1st April, 2025 and 8th April, 2025 taken on record by the Board of Directors of the Parent and the reports of the statutory auditors of its subsidiary companies, associate companies and joint venture companies incorporated in India, none of the directors of the Group companies, its associate companies and joint venture companies incorporated in India is disqualified as on 31st March, 2025 from being appointed as a director in terms of Section 164(2) of the Act.
- f) The modification relating to the maintenance of accounts and other matters connected therewith, is as stated in paragraph (b) above.
- g) With respect to the adequacy of the internal financial controls with reference to Consolidated Financial Statements and the operating effectiveness of such controls, refer to our separate Report in "Annexure A" which is based on the auditors' reports of the Parent, subsidiary companies, associate companies and joint venture companies incorporated in India. Our report expresses an unmodified opinion on the adequacy and operating effectiveness of internal financial controls with reference to Consolidated Financial Statements of those companies.
- h) With respect to the other matters to be included in the Auditor's Report in accordance with the requirements of Section 197(16) of the Act, as amended, in our opinion and to the best of our information and according to the explanations given to us and based on the auditor's reports of subsidiary companies, associate companies and joint venture companies incorporated in India, the remuneration paid by the Parent and such subsidiary companies, associate companies and joint venture companies to their respective directors during the year is in accordance with the provisions of Section 197 read with Schedule V of the Act.

- i) With respect to the other matters to be included in the Auditor's Report in accordance with Rule 11 of the Companies (Audit and Auditors) Rules, 2014, as amended, in our opinion and to the best of our information and according to the explanations given to us and based on the auditor's reports of subsidiary companies, associate companies and joint venture companies incorporated in India:
 - i) The Consolidated Financial Statements disclose the impact of pending litigations on the consolidated financial position of the Group, its associates and joint ventures – Refer Note 33.3, 33.4 and 34 to the Consolidated Financial Statements.
 - ii) Provision has been made in the Consolidated Financial Statements, as required under the applicable law or accounting standards, for material foreseeable losses, if any, on long-term contracts including derivative contracts - Refer Note 19 to the Consolidated Financial Statements.
 - iii) There has been no delay in transferring amounts, required to be transferred, to the Investor Education and Protection Fund by the Parent and its subsidiary companies, associate companies and joint venture companies incorporated in India, except for an amount of ₹ 2 crore which are held in abeyance due to pending legal cases at the Parent.
 - iv) (a) The respective Managements of the Parent and its subsidiaries, associates and joint ventures which are companies incorporated in India, whose financial statements have been audited under the Act, have represented to us and to the other auditors of such subsidiaries, associates and joint ventures respectively that, to the best of their knowledge and belief, no funds have been advanced or loaned or invested (either from borrowed funds or share premium or any other sources or kind of funds) by the Parent or any of such subsidiaries, associates and joint ventures to or in any other person(s) or entity(ies), including foreign entities ("Intermediaries"), with the understanding, whether recorded in writing or otherwise, that the Intermediary shall, directly or indirectly lend or invest in other persons or entities identified in any manner whatsoever by or on behalf of the Parent or any of such subsidiaries, associates and joint ventures ("Ultimate Beneficiaries") or provide any guarantee, security or the like on behalf of the Ultimate Beneficiaries.

- (b) The respective Managements of the Parent and its subsidiaries, associates and joint ventures which are companies incorporated in India, whose financial statements have been audited under the Act, have represented to us and to the other auditors of such subsidiaries, associates and joint ventures respectively that, to the best of their knowledge and belief, no funds have been received by the Parent or any of such subsidiaries, associates and joint ventures from any person(s) or entity(ies), including foreign entities ("Funding Parties"), with the understanding, whether recorded in writing or otherwise, that the Parent or any of such subsidiaries, associates and joint ventures shall, directly or indirectly, lend or invest in other persons or entities identified in any manner whatsoever by or on behalf of the Funding Party ("Ultimate Beneficiaries") or provide any guarantee, security or the like on behalf of the Ultimate Beneficiaries.
- (c) Based on the audit procedures performed that have been considered reasonable and appropriate in the circumstances performed by us and that performed by the auditors of the subsidiary companies, associate companies and joint venture companies which are companies incorporated in India whose financial statements have been audited under the Act, nothing has come to our or other auditor's notice that has caused us or the other auditors to believe that the representations under sub-clause (i) and (ii) of Rule 11(e) of the Companies (Audit and Auditors) Rules, 2014, as provided under (a) and (b) above, contain any material misstatement.
- v) The final dividend proposed in the previous year, declared and paid by the Parent and its associate companies which are companies incorporated in India, whose financial statements have been audited under the Act, where applicable, during the year is in accordance with Section 123 of the Act, as applicable.

The interim dividend declared and paid by the subsidiary companies which are companies incorporated in India, whose financial statements have been audited under the Act, where applicable, during the year and until the

date of this report is in accordance with Section 123 of the Act, as applicable.

The Board of Directors of the Parent and its associate companies which is a companies incorporated in India, whose financial statements have been audited under the Act, where applicable, have proposed final dividend for the year which is subject to the approval of the members of the Parent and such associate companies at the ensuing respective Annual General Meetings. Such dividend proposed is in accordance with Section 123 of the Act, as applicable.

- vi) Based on our examination which included test checks and based on the other auditor's reports of its subsidiary companies, associate companies and joint venture companies which are companies incorporated in India whose financial statements have been audited under the Act, except for the instances mentioned below including certain vendor provided software applications which feed into the principal accounting software, the Parent, its subsidiary companies, associate companies and joint venture companies incorporated in India have used accounting software for maintaining their respective books of account for the year ended 31st March, 2025, which have a feature of recording audit trail (edit log) facility and the same has operated throughout the year for all relevant transactions recorded in the respective software.

In respect of 4 joint venture companies, in the absence of the independent auditor's report in relation to controls at the service organisation for the accounting software operated by a third party software service provider, the other auditor is unable to comment whether audit trail feature for the said software was enabled and operated from 1st February, 2025 to 31st March, 2025 for all the relevant transactions recorded in the software, and in respect of 3 subsidiaries (including 2 acquired subsidiaries), certain accounting software used by the subsidiary companies for maintaining its books of account for the year ended 31st March,

2025 did not have a feature of recording audit trail (edit log) facility at an application level and / or at database level, as reported by the respective auditors.

In respect of 4 subsidiary (including 1 acquired subsidiary) and 4 associate companies, certain accounting software system's audit trail feature was not enabled for part of the year at an application level and / or at database level, as reported by the respective auditors.

Further, during the course of our audit, we and the respective other auditors, whose reports have been furnished to us by the Management of the Parent, have not come across any instance of the audit trail feature being tampered with in respect of the accounting software systems for the period for which the audit trail feature was operating.

Where audit trail was not enabled at the database level for certain software systems by 1 acquired subsidiary and 4 associates, we are unable to comment whether there were any instances of the audit trail feature being tampered with.

Additionally, the audit trail has been preserved by the Parent and subsidiary companies, associate companies and joint venture companies incorporated in India as per the statutory requirements for record retention for the period for which the audit trail feature was operating. As audit trail feature was not enabled by 20 subsidiaries, 10 associates and 2 joint venture companies for the year ended 31st March, 2024, the reporting under Rule 11(g) of the Companies (Audit and Auditors) Rules, 2014 on preservation of audit trail for the aforesaid period as per the statutory requirements for record retention is not applicable.

- 2. As required by the Companies (Auditor's Report) Order, 2020 ("the Order") issued by the Central Government of India in terms of Section 143(11) of the Act, we give in the "Annexure B" a statement on the matters specified in paragraphs 3 and 4 of the Order, to the extent applicable.

to the Consolidated Financial Statements for the year ended 31st March, 2025

A. Corporate Information

The Consolidated Financial Statements comprise financial statements of "Reliance Industries Limited" ("the Company") and its subsidiaries (collectively referred to as "the Group") for the year ended 31st March, 2025.

The Company is a listed entity incorporated in India. The registered office of the Company is located at 3rd Floor, Maker Chambers IV, 222, Nariman Point, Mumbai - 400 021, India.

The principal activities of the Group, its joint ventures and associates consist of Oil to Chemicals (O2C), Oil and Gas, Retail and Digital Services. Further details about the business operations of the Group are provided in Note 37 – Segment Information.

B. Material Accounting Policies

B.1 Basis of Preparation and Presentation

The Consolidated Financial Statements have been prepared on the historical cost basis except for the following assets and liabilities which have been measured at fair value:

- i. Certain Financial Assets and Liabilities (including derivative instruments),
- ii. Defined Benefit Plan's – Plan Assets, and
- iii. Equity settled Share Based Payments

The Consolidated Financial Statements of the Group have been prepared in accordance with Indian Accounting Standards (Ind AS) notified under the Companies (Indian Accounting Standards) Rules, 2015 (as amended from time to time) and presentation requirements of Division II of Schedule III to the Companies Act, 2013, (Ind AS compliant Schedule III), as applicable to the Consolidated Financial Statements. The Group follows indirect method prescribed in Ind AS 7 – Statement of Cash Flows for presentation of its cash flows.

The Consolidated Financial Statements comprises of Reliance Industries Limited and all its subsidiaries, being the entities that it controls. Control is assessed in accordance with the requirement of Ind AS 110 – Consolidated Financial Statements.

The Consolidated Financial Statements are presented in Indian Rupees (₹) and all values are rounded to the nearest crore (₹ 00,00,000), except when otherwise indicated.

B.2 Principles of Consolidation

- (a) The financial statements of the Company and its subsidiaries are combined on a line-by-line basis by adding together like items of assets, liabilities,

equity, incomes, expenses and cash flows, after fully eliminating intra-group balances and intra-group transactions.

- (b) Profits or losses resulting from intra-group transactions that are recognised in assets, such as Inventory and Property, Plant and Equipment, are eliminated in full.
- (c) In case of foreign subsidiaries, revenue items are consolidated at the average rate prevailing during the year. All assets and liabilities are converted at rates prevailing at the end of the year. Any exchange difference arising on consolidation is recognised in the Foreign Currency Translation Reserve (FCTR).
- (d) The audited / unaudited financial statements of foreign subsidiaries / joint ventures / associates have been prepared in accordance with the Generally Accepted Accounting Principle of its Country of Incorporation or Ind AS.
- (e) The differences in accounting policies of the Company and its subsidiaries / joint ventures / associates are not material and there are no material transactions from 1st January, 2025 to 31st March, 2025 in respect of subsidiaries / joint ventures / associates having financial year ended 31st December 2024.

B.3 Summary of Material Accounting Policies

(a) Current and Non-Current Classification

The Group present assets and liabilities in the Balance Sheet based on Current / Non-Current classification considering an operating cycle of 12 months being the time elapsed between deployment of resources and the realisation / settlement in cash and cash equivalents there-against.

(b) Business Combination

For each business combination, the Group elects whether to measure the non-controlling interests in the acquiree at fair value or at the proportionate share of the acquiree's identifiable net assets.

(c) Property, Plant and Equipment

Property, Plant and Equipment are stated at cost, net of recoverable taxes, trade discount and rebate less accumulated depreciation and impairment loss, if any. Such cost includes purchase price, borrowing cost and any cost directly attributable to bringing the assets to its working condition for its intended use, net charges on foreign exchange contracts and adjustments arising from exchange rate variations attributable to the assets. In case of land the Group has availed fair value as deemed cost on the date of transition to Ind AS.

Other Indirect Expenses incurred relating to project, net of income earned during the project development stage prior to its intended use, are considered as pre-operative expenses and disclosed under Capital Work-in-Progress.

Depreciation on Property, Plant and Equipment is provided using written down value method on depreciable amount except in case of certain assets of Oil to Chemicals and Other Segment, which are depreciated using straight-line method. Depreciation is provided based on useful life of the assets as prescribed in Schedule II to the Companies Act, 2013 except in respect of the following assets, where useful life is as under:

The residual values, useful lives and methods of depreciation of Property, Plant and Equipment are reviewed at each financial year end and adjusted prospectively, if appropriate.

(d) Leases

The Group, as a lessee, recognises a right-of-use asset and a lease liability for its leasing arrangements, if the contract conveys the right to control the use of an identified asset. Initially the right-of-use assets measured at cost which comprises initial cost of the lease liability adjusted for any lease payments made at or before the commencement date plus any initial direct costs incurred. Subsequently measured at cost less any accumulated depreciation / amortisation, accumulated impairment losses, if any and adjusted for any remeasurement of the lease liability.

The right-of-use assets is depreciated / amortised using the straight-line method from the commencement date over the shorter of lease term or useful life of right-of-use asset.

The Group measures the lease liability at the present value of the lease payments that are not paid at the commencement date of the lease. The lease payments are discounted using the interest rate implicit in the lease, if that rate can be readily determined. If that rate cannot be

readily determined, the Group uses incremental borrowing rate.

For short-term and low value leases, the Group recognises the lease payments as an operating expense on a straight-line basis over the lease term.

(e) Intangible Assets

Intangible Assets are stated at cost of acquisition net of recoverable taxes, trade discount and rebate less accumulated amortisation / depletion and impairment loss, if any. Such cost includes purchase price, borrowing costs, and any cost directly attributable to bringing the asset to its working condition for the intended use, net charges on foreign exchange contracts and adjustments arising from exchange rate variations attributable to the Intangible Assets.

Other Indirect Expenses incurred relating to project, net of income earned during the project development stage prior to its intended use, are considered as pre-operative expenses and disclosed under Intangible Assets Under Development.

The Group assesses if useful life of an intangible asset is finite or indefinite. A summary of the amortisation / depletion policies applied to the Group's Intangible Assets with a finite life to the extent of depreciable amount is as follows.

The amortisation period and the amortisation method for Intangible Assets with a finite useful life are reviewed at each reporting date.

(f) Inventories

Items of inventories are measured at lower of cost and net realisable value after providing for obsolescence, if any, except in case of by-products which are valued at net realisable value.

Cost of finished goods, work-in-progress, raw materials, chemicals, stores and spares, packing materials, trading and other products are determined on weighted average basis.

(g) Provisions

Provisions are recognised when the Group has a present obligation (legal or constructive) as a result of a past event, it is probable that an outflow of resources embodying economic benefits will be required to settle the obligation and a reliable estimate can be made of the amount of the obligation. If the effect of the time value of money is material, provisions are discounted using a current pre-tax rate that reflects, when appropriate, the risks specific to the liability. When discounting is used, the increase in the provision due to the passage of time is recognised as a finance cost.

Provision for Decommissioning Liability

The Group records a provision for decommissioning costs towards site restoration activity. Decommissioning costs are provided at the present value of future expenditure using a current pre-tax rate expected to be incurred to fulfil decommissioning obligations and are recognised as part of the cost of the underlying assets. Any change in the present value of the expenditure, other than unwinding of discount on the provision, is reflected as adjustment to the provision and the corresponding asset. The change in the provision due to the unwinding of discount is recognised in the Consolidated Statement of Profit and Loss.

(h) Contingent Liabilities

Disclosure of contingent liability is made when there is a possible obligation arising from past events, the existence of which will be confirmed only by the occurrence or non-occurrence of one or more uncertain future events not wholly within the control of the Group or a present obligation that arises from past events where it is either not

probable that an outflow of resources embodying economic benefits will be required to settle or a reliable estimate of amount cannot be made.

(i) Current Tax and Deferred Tax

The tax expenses for the period comprise of current tax and deferred tax. The Group exercises judgment in computation of current tax considering the relevant rulings and reassesses the carrying amount of deferred tax assets / liabilities at the end of each reporting period.

(j) Share Based Payments

In case of Group equity-settled share-based payment transactions, where the Company grants stock options to the employees of its subsidiaries, the transactions are accounted by increasing the cost of investment in subsidiary with a corresponding credit in the equity.

(k) Foreign Currencies Transactions and Translation

Exchange gains or losses on foreign currency borrowings taken prior to 1st April, 2016 which are related to the acquisition or construction of qualifying assets are adjusted in the carrying cost of such assets.

(l) Revenue Recognition

Revenue from contracts with customers is recognised when control of the goods or services are transferred to the customer at an amount that reflects the consideration entitled in exchange for those goods or services. The Group is generally considered as principal, as it typically controls the goods or services before transferring them to the customer.

Revenue is measured at the amount of consideration which the Group expects to be entitled to in exchange for transferring distinct goods or services to a customer as specified in the contract, excluding amounts collected on behalf of third parties (for example taxes and duties collected on behalf of the government). Consideration is generally due upon satisfaction of performance obligations and a receivable is recognised when it becomes unconditional. Generally, the credit period varies between 0-60 days from the shipment or delivery of goods or completion of services as the case may be. The Group provides volume rebates to certain customers once the quantity of products purchased during the period exceeds a threshold specified and also accrues discounts to certain customers based on customary business practices which is derived on the basis of crude price volatility and various market demand – supply situations. Consideration are determined based on

its most likely amount. Generally, sales of petroleum products contain provisional pricing features where revenue is initially recognised based on provisional price. Difference between final settlement price and provisional price is recognised subsequently.

(m) Financial Instruments

i. Financial Assets

Purchase and sale of Financial Assets are recognised using trade date accounting. Trade receivables that do not contain a significant financing component are measured at transaction price.

The investments in associates and joint venture are accounted on equity method.

All other equity investments are measured at fair value, with value changes recognised in Statement of Profit and Loss, except for those equity investments for which the Group has elected to present the value changes in 'Other Comprehensive Income'. However, dividend on such equity investments are recognised in Statement of Profit and Loss when the Company's right to receive payment is established. The investments in preference shares with the right to surplus assets which are in nature of equity in accordance with Ind AS 32 are treated as separate category of investment and measured at Fair Value Through Other Comprehensive Income (FVTOCI). Other Financial Assets are generally measured at Fair Value Through Profit or Loss (FVTPL) except where the Group, based on the business model objectives, measures these at Amortised Cost or Fair Value Through Other Comprehensive Income (FVTOCI).

The Group uses 'Expected Credit Loss' (ECL) model, for evaluating impairment of Financial Assets other than those measured at Fair Value Through Profit or Loss (FVTPL).

Expected Credit Losses are measured through a loss allowance at an amount equal to:

- The 12-months expected credit losses (expected credit losses that result from those default events on the financial instrument that are possible within 12 months after the reporting date); or
- Full lifetime expected credit losses (expected credit losses that result from all possible default events over the life of the financial instrument).

For Trade Receivables, the Group applies 'simplified approach' which requires expected lifetime losses to be recognised from initial recognition of the receivables.

The Group uses historical default rates to determine impairment loss on the portfolio of trade receivables. At every reporting date these historical default rates are reviewed and changes in the forward-looking estimates are analysed.

For other assets, the Group uses 12 month ECL to provide for impairment loss where there is no significant increase in credit risk. If there is significant increase in credit risk full lifetime ECL is used.

ii. Financial Liabilities

For trade and other payables maturing within one year from the balance sheet date, the carrying amounts are determined to approximate fair value due to the short maturity of these instruments.

iii. Derivative Financial Instruments and Hedge Accounting

The Group uses various derivative financial instruments such as interest rate swaps, currency swaps, forwards & options and commodity contracts to mitigate the risk of changes in interest rates, exchange rates and commodity prices. At the inception of a hedge relationship, the Group formally designates and documents the hedge relationship to which the Group wishes to apply hedge accounting and the risk management objective and strategy for undertaking the hedge.

Any gains or losses arising from changes in the fair value of derivatives are taken directly to Statement of Profit and Loss, except for the effective portion of cash flow hedge which is recognised in Other Comprehensive Income and later to Statement of Profit and Loss when the hedged item affects profit or loss or is treated as basis adjustment if a hedged forecast transaction subsequently results in the recognition of a Non-Financial Assets or Non-Financial liabilities.

Hedges that meet the criteria for hedge accounting are accounted for as follows:

A. Cash Flow Hedge

The Group designates derivative contracts or non-derivative Financial Assets / Liabilities as hedging instruments to mitigate the risk of movement in interest rates and foreign exchange rates for foreign exchange exposure on highly probable future cash flows attributable to a recognised asset or liability or forecast cash transactions.

B. Fair Value Hedge

The Group designates derivative contracts or non-derivative Financial Assets / Liabilities as hedging instruments to mitigate the risk of change in fair value of hedged item due to movement in interest rates, foreign exchange rates and commodity prices.

iv. Offsetting

Financial Assets and Financial Liabilities are offset and the net amount is presented in the balance sheet when, and only when, the Group has a legally enforceable right to set off the amount and it intends, either to settle them on a net basis or to realise the asset and settle the liability simultaneously.

(n) Accounting for Oil and Gas Activity

Oil and Gas Joint Arrangement are in the nature of joint operations. Accordingly, assets and liabilities as well as income and expenditure are accounted on the basis of available information on a line-by-line basis with similar items in the Financial Statements, according to the participating interest of the Group.

The Group follows the Guidance Note on Accounting for Oil and Gas producing activities – Ind AS issued by the Institute of Chartered Accountants of India for the purpose of accounting. Seismic costs, geological and geophysical studies, petroleum exploration license fees and general and administration costs directly attributable to exploration and evaluation activities are expensed off. The costs incurred on acquisition of interest in oil and gas blocks and on exploration and evaluation other than those which are expensed off are accounted for as Intangible Assets Under Development. All development costs incurred in respect of proved reserves are also capitalised under Intangible Assets Under Development. Once a well is ready to commence commercial production, the costs accumulated in Intangible Assets Under Development are classified as Intangible Assets corresponding to proved developed oil and gas reserves. The exploration and evaluation expenditure which does not result in discovery of proved oil and gas reserves and all cost pertaining to production are charged to the Statement of Profit and Loss.

The Group uses technical estimation of reserves as per the Petroleum Resources Management System guidelines 2011 and standard geological and reservoir engineering methods. The reserve review and evaluation is carried out annually.

C. CRITICAL ACCOUNTING JUDGEMENTS AND KEY SOURCES OF ESTIMATION UNCERTAINTY

The preparation of the Group's financial statements require management to make judgement, estimates and assumptions that affect the reported amount of revenue, expenses, assets and liabilities and the accompanying disclosures. Uncertainty about these assumptions and estimates could result in outcomes that require a material adjustment to the carrying amount of assets or liabilities affected in future periods.

(A) ESTIMATION OF OIL AND GAS RESERVES

The determination of the Group's estimated oil and natural gas reserves require significant judgements and estimates to be applied and these are regularly reviewed and updated. Factors such as the availability of geological and engineering data, reservoir performance data, acquisition and divestment activity, drilling of new wells, and commodity prices all impact on the determination of the Group's estimates of its oil and natural gas reserves. The Group bases its proved reserves estimates on the requirement of reasonable certainty with rigorous technical and commercial assessments based on conventional industry practice and regulatory requirements.

Estimates of oil and natural gas reserves are used to calculate depletion charges for the Group's oil and gas properties. The impact of changes in estimated proved reserves is dealt with prospectively by amortising the remaining carrying value of the asset over the expected future production. Oil and natural gas reserves also have a direct impact on the assessment of the recoverability of asset carrying values reported in the financial statements.

Details on proved reserves and production both on product and geographical basis are provided in Note 33.

(B) PROPERTY, PLANT AND EQUIPMENT / OTHER INTANGIBLE ASSETS

Estimates are involved in determining the cost attributable to bringing the assets to the location and condition necessary for it to be capable of operating in the manner intended by the management. Property, Plant and Equipment / Other Intangible Assets are depreciated / amortised over their estimated useful life, after taking into account estimated residual value. Spectrum Cost is amortised over its balance validity period, based

on the expected pattern of consumption of the expected future economic benefits.

Management reviews the estimated useful life and residual values of the assets annually in order to determine the amount of depreciation / amortisation to be recorded during any reporting period. The useful life and residual values are based on the Group's historical experience with similar assets and take into account anticipated technological and future risks. The depreciation / amortisation for future periods is revised if there are significant changes from previous estimates.

(C) PROVISIONS

The timing of recognition and quantification of the liability (including litigations) requires the application of judgement to existing facts and circumstances, which can be subject to change. The carrying amounts of provisions and liabilities are reviewed regularly and revised to take account of changing facts and circumstances.

(D) IMPAIRMENT OF GOODWILL, INTANGIBLE ASSETS UNDER DEVELOPMENT AND INTANGIBLE ASSETS WITH INDEFINITE USEFUL LIFE

Management reviews the carrying value of goodwill, intangible assets under development and intangible assets with indefinite useful life annually, to determine whether there has been any impairment by allocating the value of goodwill, intangible assets under development and intangible assets with indefinite useful life to a Cash Generating Unit (CGU). The Group has identified CGUs for this purpose, considering the nature of the businesses to which each of the CGU relates.

Value in use i.e. the enterprise value of each CGU is aggregate of cash flow projections, for five years as approved by Senior Management and beyond five years extrapolated using a long-term growth rate which ranges from 2% to 5%. Cash flow projections are discounted by a pre-tax discount rate, being the Weighted Average Cost of Capital (WACC), which ranges from 8% to 12%.

The Management believes that any reasonably possible change in the above key assumptions on which recoverable amount is based would not cause the aggregate carrying amount to exceed the aggregate recoverable amount of the CGU.

Goodwill and intangible assets with indefinite lives have been allocated to the respective CGUs. During the year ended March 31, 2025, the Group has determined that there is no impairment towards these assets.

(E) IMPAIRMENT OF FINANCIAL AND NON-FINANCIAL ASSETS

The impairment provisions for Financial Assets are based on assumptions about risk of default and expected cash loss rates. The Group uses judgement in making these assumptions and selecting the inputs to the impairment calculation, based on Group's past history, existing market conditions as well as forward-looking estimates at the end of each reporting period.

In case of non-financial assets, the Group estimates asset's recoverable amount, which is higher of an asset's or Cash Generating Units (CGU's) fair value less costs of disposal and its value in use.

In assessing value in use, the estimated future cash flows are discounted to their present value using pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset. In determining fair value less costs of disposal, recent market transactions are taken into account, if no such transactions can be identified, an appropriate valuation model is used.

(F) FAIR VALUE MEASUREMENT

For estimates relating to fair value of financial instruments refer Note 36 of Consolidated Financial Statements.

(G) LEASES

The Group evaluates if an arrangement qualifies to be a lease as per the requirements of Ind AS 116. Identification of a lease requires significant judgement. The Group uses judgement in assessing whether a contract (or part of contract) include a lease, the lease term (including anticipated renewals), the applicable discount rate, variable lease payments whether are in-substance fixed. The judgement involves assessment of whether the asset included in the contract is a fully or partly identified asset based on the facts and circumstances, whether the contract include a lease and non-lease component and if so, separation thereof for the purpose of recognition and measurement, determination of lease term basis, inter alia the non-cancellable period of lease and whether the lessee intends to opt for continuing with the use of the asset upon the expiry thereof, and whether the lease payments are fixed are variable or a combination of both.

14.6 Rights, preferences and restrictions attached to shares:

The Company has only one class of equity shares having face value of ₹ 10 each. The holder of the equity share is entitled to dividend right and voting right in the same proportion as the capital paid-up on such equity share bears to the total paid-up equity share capital of the Company. The dividend proposed by Board of Directors is subject to approval of the shareholders in the ensuing Annual General Meeting. In the event of liquidation of the Company, the holders of equity shares will be entitled to receive the remaining assets of the Company in the same proportion as the capital paid-up on the equity shares held by them bears to the total paid-up equity share capital of the Company.

14.7 Issue of Shares Under Rights Issue:

The Company had issued 42,26,26,894 equity shares of face value of ₹ 10/- each on right basis ('Rights Equity Shares'). In accordance with the terms of issue, ₹ 314.25 i.e. 25% of the Issue Price per Rights Equity Share, was received from the concerned allottees on application and shares were allotted. The Board had made First call of ₹ 314.25 per Rights Equity Share (including a premium of ₹ 311.75 per share) in May, 2021 and Second and Final call of ₹ 628.50 per Rights Equity Share (including a premium of ₹ 623.50 per share) in November, 2021. During the year under review, 2,74,853 partly paid up shares became fully paid up shares and 1,42,565 shares, on which an amount of ₹ 4,31,315 was paid-up, were forfeited and cancelled.

14.8 Bonus Shares Issued During the Current Financial Year:

On October 29, 2024, the Company had allotted 676,61,86,449 bonus equity shares of ₹ 10/- each (fully paid up) in the proportion of 1 bonus equity share for every 1 fully paid up equity share to eligible shareholders whose names appeared in the Register of Members / Register of Beneficial Owner as on October 28, 2024, being the record date fixed for this purpose, in accordance with approval received from the Members by way of postal ballot, result of which was declared on October 16, 2024. The said bonus equity shares rank pari passu in all respects with the existing equity shares of the Company. As a result of the bonus issue, the paid-up capital of the Company increased to ₹ 13,532 crore from ₹ 6,766 crore. The paid-up capital on account of bonus issue of ₹ 6,766 crore has been appropriated from securities premium.

The reserve estimates for producing fields are revised based on the performance of producing fields and with respect to discovered fields, the revision are based on the revised geological and reservoir simulation studies.

33.3 The Government of India ("GoI"), disallowed certain costs which the Production Sharing Contract ("PSC"), relating to Block KG-DWN-98/3 ("KG D6") entitles the Company to recover. The Company maintains that the Contractor is entitled to recover all of its costs under the terms of the PSC and there are no provisions that entitle the GoI to disallow the recovery of any Contract Cost. The Company referred the issue to arbitration with GoI for resolution of disputes. The matter is presently at the stage of Final Hearing as part of arbitration proceedings. The demand from the GoI of \$ 165 million (for ₹ 1,407 crore) being the Company's share (total demand \$ 247 million – ₹ 2,111 crore) towards additional Profit Petroleum has been considered as contingent liability as on 31st March 2025.

In supersession of the Ministry's Gazette notification no. 22011/3/2012-ONG.D.V. dated 10th January 2014, the GoI notified the New Domestic Natural Gas Pricing Guidelines, 2014 on 26th October 2014. The GoI had directed the Company to instruct customers to deposit differential revenue on gas sales from D1D3 field on account of the prices determined under the guidelines converted to NCV basis and the prevailing price prior to 1st November 2014 (\$ 4.205 per MMBTU) to be credited to the gas pool account maintained by GAIL (India) Limited. The amount so deposited by customer to Gas Pool Account is ₹ 295 crore (net) as at 31st March 2025. Revenue has been recognised at the GoI notified prices on GCV basis, in respect of gas quantities sold from D1D3 field from 1st November 2014. This amount in the Gas Pool Account has also been challenged under cost recovery arbitration and is pending adjudication.

33.4 (a) Government of India ("GoI") sent a demand notice to the KG D6 block contractor (RIL, BP Exploration (Alpha) Limited and Niko (NECO) Limited) (together "Contractor") on 3rd November 2016, on account of production of gas allegedly migrated from ONGC's blocks. RIL, as operator and on behalf of the Contractor, initiated arbitration proceedings against the GoI. The Arbitral Tribunal vide its Final Award dated 24th July 2018 ("Arbitration Award"), upheld Contractor's claims. Vide Judgment dated 9th May 2023, a single judge of the Hon'ble Delhi High Court upheld the Arbitration Award and dismissed GoI's appeal challenging the award. On an appeal by GoI, vide judgment dated 14th February 2025, the Division Bench of the Hon'ble Delhi High Court allowed GoI's appeal and set aside the judgment of the single judge and the Arbitration Award.

A demand letter dated 1st March 2025 for payment of \$ 2.81 billion (RIL share \$ 1.87 billion) was sent by GoI to the Contractor. RIL, on 17th March 2025, responded that it is not liable to make any payment to GoI and that the demand letter is without any factual or legal basis and is liable to be withdrawn. RIL will be filing an appeal against the judgement of the Division Bench of the Hon'ble Delhi High Court.

(b) Arbitration was initiated by BG Exploration and Production India Limited and the Company (together the Claimants) against GoI under the PSCs for Panna – Mukta and Tapti blocks due to difference in interpretation of certain PSC provisions between Claimants and GoI. The Arbitration Tribunal has issued a number of final partial awards in this matter, some of which have (in part) not been in Claimant's favour. The arbitration is ongoing and a final award is yet to be issued. The arbitration has also led to satellite litigation in India (presently ongoing) and in the UK, which has resulted in court judgements that have not always been entirely in RIL's favour.

(c) NTPC filed suit in 2006 for specific performance of contract for supply of natural gas of 132 trillion BTU annually for a period of 17 years. This suit is still pending adjudication in the Bombay High Court and the Company's fact witnesses in the suit are to be cross examined by NTPC. On 2nd December 2024, an SLP was filed by RIL before the Supreme Court against an Order of the Bombay High Court in the NTPC suit, directing redaction of certain portions of RIL's Affidavit. The matter is presently sub-judice.

Considering the complexity of above issues, the Company is of the view that any attempt for quantification of possible exposure to the Company will have an effect of prejudicing Company's legal position in the ongoing arbitration / litigations. Moreover, the Company considers above demand / disputes as remote.

(III) On December 16, 2010, the Securities and Exchange Board of India (SEBI) issued a show cause notice ("SCN") inter alia to the Company (RIL) in connection with the trades by RIL in the stock exchanges in 2007 in the shares of Reliance Petroleum Limited, then a subsidiary of RIL. By an order dated March 24, 2017, the Whole Time Member ("WTM") passed directions: (i) prohibiting inter alia RIL from dealing in equity derivatives in the 'Futures & Options' segment of stock exchanges, directly or indirectly, for a period of one year from the date of the order; and (ii) to disgorge from RIL an amount of ₹ 447 crore along with interest at the rate of 12% per annum from November 29, 2007, till the date of payment. On an appeal by RIL, Securities Appellate Tribunal ("SAT") by a majority order (2:1), dismissed the appeal on November 5, 2020, and directed RIL to pay the disgorged amount within sixty days from the date of the order. The appeal of RIL and others has been admitted by the Hon'ble Supreme Court of India. By its order dated December 17, 2020, the Hon'ble Supreme Court of India directed RIL to deposit ₹ 250 crore in the Investors' Protection Fund, subject to the final result of the appeal and stayed the recovery of the balance, inclusive of interest, pending the appeal. RIL has complied with the order dated December 17, 2020, of the Hon'ble Supreme Court of India.

In the above matter, the adjudicating officer of SEBI ("AO") while adjudicating the show cause notice dated November 21, 2017 issued, inter alia, to RIL passed an order on January 1, 2021 imposing a penalty of ₹ 25 crore on RIL. In the appeal filed by RIL, the Hon'ble Securities Appellate Tribunal vide order dated December 4, 2023, did not interfere with the order passed by the AO since the matter was already covered by its earlier decision dated November 5, 2020, which is in appeal by RIL before the Hon'ble Supreme Court. RIL has filed an appeal in the Hon'ble Supreme Court of India against Order dated December 4, 2023 of SAT. The Company continues to consider the aforesaid liability as contingent.

(IV) Hathway Cable and Datacom Limited has received Show Cause cum Demand notices ("SCNs") from the Department of Telecommunications ("DOT"), Government of India towards license fees aggregating to ₹ 3,202 crore which includes penalty and interest thereon (March 31, 2024: ₹ 3,202 crore including penalty and interest). The Group has made representations to DOT contesting the basis of such demands. Based on opinion of legal expert, the Group is confident that it has good grounds on merit to defend itself in the above matter. Accordingly, the Group is of the view that no provision is necessary in respect of the aforesaid matter.

(V) Den Networks Limited ("DEN") has received demand of ₹ 628 crore from the Department of Telecom (DOT) during provisional assessment towards the license fees for the years 2010-11 to 2015-16 considering revenue from the cable business and other income for the purpose of calculating AGR or license fees. Demand was initially raised on DEN. However, revised demand of ₹ 2,157 crore including interest and penalty calculated up till date has been raised on Den Broadband Limited (wholly owned subsidiary of DEN) for the years 2011-2012 to 2015-2016. In view of management and based on legal opinion obtained, these demands are unenforceable. DEN has filed various petitions before the Hon'ble TDSAT challenging these demands. In all the petitions, the Hon'ble TDSAT has restrained DOT from taking any coercive measure for realisation of the demands.

35. Capital Management

The Group adheres to a disciplined Capital Management framework in order to maintain a strong balance sheet. The main objectives are as follows:

- Maintain investment grade ratings for all issuing entities, domestically and internationally by ensuring that the financial strength of their Balance Sheets are preserved.
- Manage foreign exchange, interest rates and commodity price risk, and minimise the impact of market volatility on earnings.
- Diversify sources of financing and spread the maturity across tenure buckets in order to manage liquidity risk.
- Leverage optimally in order to maximise shareholder returns.

Valuation Methodology

All financial instruments are initially recognised and subsequently re-measured at fair value as described below:

- The fair value of investment in quoted Equity Shares, Bonds, Government Securities, Treasury Bills, Certificate of Deposits and Mutual Funds is measured at quoted price or NAV.
- The fair value of Interest Rate Swaps is calculated as the present value of the estimated future cash flows based on observable yield curves.
- The fair value of Forward Foreign Exchange contracts and Currency Swaps is determined using observable forward exchange rates and yield curves at the balance sheet date.
- The fair value of over-the-counter Foreign Currency Option contracts is determined using the Black Scholes valuation model.
- Commodity derivative contracts are valued using available information in markets and quotations from exchange, brokers and price index developers.
- The fair value for Level 3 instruments is valued using inputs based on information about market participants assumptions and other data that are available.
- The fair value of the remaining financial instruments is determined using discounted cash flow analysis.
- All foreign currency denominated assets and liabilities are translated using exchange rate at reporting date.

B. Financial Risk Management

The Group's activities expose it to variety of financial risks: market risk (including foreign currency risk and interest rate risk), commodity price risk, credit risk, and liquidity risk. Within the boundaries of approved Risk Management Policy framework, the Group uses derivative instruments to manage the volatility of financial markets and minimise the adverse impact on its financial performance.

i) Market Risk

Market risk is the risk that the fair value of future cash flows of a financial instrument will fluctuate because of changes in market prices. Market risk comprises three types of risk: interest rate risk, currency risk and other price risk, such as equity price risk and commodity risk.

a) Foreign Currency Risk

Foreign Currency Risk is the risk that the Fair Value or Future Cash Flows of an exposure will fluctuate because of changes in foreign currency rates. Exposures can arise on account of the various assets and liabilities which are denominated in currencies other than Indian Rupee.

ii) Commodity Price Risk

Commodity price risk arises due to fluctuation in prices of crude oil, other feed stock and products and bullion. The Group has a risk management framework aimed at prudently managing the risk arising from the volatility in commodity prices and freight costs.

The Group's commodity price risk is managed centrally through well-established trading operations and control processes. In accordance with the risk management policy, the Group enters into various transactions using derivatives and uses over-the-counter as well as Exchange Traded Futures, Options and Swap contracts to hedge its commodity and freight exposure.

iii) Credit Risk

Credit risk is the risk that a customer or counterparty to a financial instrument fails to perform or pay the amounts due causing financial loss to the Group. Credit risk arises from Group's activities in investments, dealing in derivatives and receivables from customers and other financial instruments. The Group ensures that sales of products are made to customers with appropriate creditworthiness. Credit information is regularly shared between businesses and finance function, with a framework in place to quickly identify, respond and recognise cases of credit deterioration.

The Group has a prudent and conservative process for managing its credit risk arising in the course of its business activities. Credit risk across the Group, is actively managed through Letters of Credit, Bank Guarantees, Parent Group Guarantees, advance payments, security deposits and factoring and forfaiting without recourse to Group. The Group restricts its fixed income investments in liquid securities carrying high credit rating.

iv) Liquidity Risk

Liquidity risk arises from the Group's inability to meet its cash flow commitments on the due date. The Group maintains sufficient stock of cash, marketable securities and committed credit facilities. The Group accesses global and local financial markets to meet its liquidity requirements. It uses a range of products and a mix of currencies to ensure efficient funding from across well-diversified markets and investor pools. Treasury monitors rolling forecasts of the Group's cash flow position and ensures that the Group is able to meet its financial obligation at all times including contingencies.

The Group's liquidity is managed centrally with operating units forecasting their cash and liquidity requirements. Treasury pools the cash surpluses from across the different operating units and then arranges to either fund the net deficit or invest the net surplus in a range of short-dated, secure and liquid instruments including short-term bank deposits, money market funds, reverse repos and similar instruments. The portfolio of these investments is diversified to avoid concentration risk in any one instrument or counterparty.

C. Hedge Accounting

The Group's business objective includes safe-guarding its earnings against adverse price movements of crude oil and other feedstock, refined products, precious metals, freight costs as well as foreign exchange and interest rates. The Group has adopted a structured risk management policy to hedge all these risks within an acceptable risk limit and an approved hedge accounting framework which allows for Fair Value and Cash Flow hedges. Hedging instruments include exchange traded futures and options, over-the-counter swaps, forwards and options as well as non-derivative instruments to achieve this objective.

There is an economic relationship between the hedged items and the hedging instruments. The Group has established a hedge ratio of 1:1 for the hedging relationships. To test the hedge effectiveness, the Group uses the hypothetical derivative method and Dollar offset method.

The hedge ineffectiveness can arise from:

- Differences in the timing of the cash flows.
- Different indexes (and accordingly different curves).
- The counterparties' credit risk differently impacting the fair value movements.

42. Significant Arrangements

Composite Scheme of Arrangement amongst Viacom 18 Media Private Limited (now known as Studio 18 Media Private Limited) (Viacom18), Digital18 Media Private Limited (Digital18) and Star India Private Limited (SIPL) and their respective shareholders and creditors ("Scheme"):

The above Scheme was sanctioned by the Hon'ble National Company Law Tribunal, Mumbai Bench vide Order dated August 30, 2024. The Scheme became effective on November 14, 2024. In terms of the Scheme:

- (a) The Media Operations Undertaking and the Jio Cinema Undertaking of Viacom18 were transferred on slump sale basis to Digital18, a wholly owned subsidiary of Viacom18 and Digital18 issued and allotted 26,95,62,52,977 fully paid-up equity shares of ₹ 10 each at par;
- (b) The Company invested ₹ 11,500 crore towards subscription of 26,05,19,406 equity shares of SIPL, as a condition precedent to the effectiveness of the Scheme;
- (c) The Media Operations Business and the Jio Cinema Business transferred from Viacom18 to Digital18 (refer (a) above) except the business of production and distribution of motion pictures was demerged from Digital18 into SIPL and SIPL issued and allotted to Viacom 18,74,61,50,236 fully paid-up equity shares of ₹ 10 each at par (valuation of ₹ 32,937 crore).

Total consideration for (b) and (c) being ₹ 44,437 crore (₹ 11,500 crore + ₹ 32,937 crore).

The aforesaid resulted in SIPL becoming a 63.16 % subsidiary of Reliance Industries Limited. The Group derives synergies from SIPL's superior content, OTT Platform and brand recall to augment its presence in the media space. This transaction has been accounted for by the Group in accordance with the requirements of Ind AS 103 applicable to reverse acquisitions. Accordingly, the consideration issued by the Group of ₹ 44,437 crore, has been appropriated over identifiable assets and liabilities of SIPL, being non-current and current assets of ₹ 13,527 crore and ₹ 24,866 crore respectively, non-current and current liabilities of ₹ 679 crore and ₹ 8,489 crore respectively, recognition of onerous contract of ₹ 22,129 crore, recognition of brand of ₹ 31,513 crore, with the balancing figure being goodwill of ₹ 5,828 crore. This acquisition does not have a material impact on the consolidated revenue and consolidated profits of the Group for the current year.

43. Events after the Reporting Period

The Board of Directors have recommended dividend of ₹ 5.5/- per fully paid up equity share of ₹ 10/- each for the financial year 2024-25 aggregating ₹ 7,443 crore.

44. The figures for the corresponding previous year have been regrouped / reclassified wherever necessary, to make them comparable.

45. Approval of Financial Statements

The Consolidated Financial Statements were approved for issue by the Board of Directors on April 25, 2025.
